Wests Resign After 21 Years in Côte d'Ivoire: Robert and Pam West, who were appointed to Côte d'Ivoire in 1982 as maintenance missionaries for the hospital in Doropo, have submitted their resignation from service as general church-planting missionaries in Kafolo in northern Ivory Coast.

The Wests returned to Côte d'Ivoire in June after having been forced to leave the country during the coup d'etat near the end of 2002. They joined Jerry and Carol Pinkerton who had returned a few days earlier. The two couples remained in Abidjan, but recently Robert and Jerry made a trip to the north to assess the works in rebel-controlled areas.



Finding unstable conditions in the Kafolo area, sensing the inability to physically handle the stress of those conditions, and feeling unsuited for working in the mega-city of Abidjan, Robert and Pam determined they are better equipped for a stateside ministry of some kind.

"God has blessed these 21 years," declare the Wests. "We praise God for the privilege and opportunity to have been involved in reaching the world for Christ. We will continue to be missionaries in our hearts."

The Board of Foreign Missions accepted the couple's resignation and expressed gratitude and appreciation for their years of fruitful ministry. Their official date of resignation is September 30. They are scheduled to return to the States late in September.

Below are the two church related Schools that replyed to a letter sent to every church in the state asking for information about any school ministry at their Church.

The first class was K-5 and it consisted of 3 students. A day care was also provided. Through the years the school had grown and added grades until this year they are K-5 through the 12th grade with an enrollment of 183. Mrs Gwen Ard is the present principal and Rev. Phillip Tipton is the Pastor.



Southside FWB Kindergarten/Day Care. A ministry of Southside FWB Church, Darlington. This school began in



January of 1998 with one teacher and grades 3-K through 5-K in one room. The next year they divided the classes with a teacher for each class. The first year started with 6 students and attendance has grown each year with 35 in attendance last year.

The Students from this school have scored very highly when they go on to public or private schools and the ministry of the school has had a very good effect on the families of the community. #### THE CAPE FEAR MYSTERY

History can be like the rolling tide of the ocean, allowing us to catch a glimpse of treasure long ago buried in the sands, but covering it again before we can truly understand or appreciate it. Such is the case when considering the origins of the Cape Fear Conference of North Carolina, and its relationship with the South Carolina General Conference. On the surface it appears to be a relatively simple matter, but it quickly becomes a murky situation that raises more questions than it answers.

The oddity of the matter becomes quickly apparent when it is understood that there are no references in the minutes of the South Carolina General Conference to indicate that any official relationship ever existed tists written by between the two bodies. There are only occasional references to delegates from each conference visiting the other and extending greetings. The pertinent facts of this puzzling series of events are largely found in the records of the Pentecostal Free Will Baptist General Conference in North Carolina. By 1855, there were eight member of the Free Will Baptist Churches in the area of Fayetteville and Dunn, in North Carolina. These churches were Stoney Run, Long Branch, Free Union, Fayetteville, Bethsaida, Shady Grove, Prospect and Elbethel. Dr. Herbert sion Carter, historian for the Pentecostal Free Will Baptist Church, says these churches "...were a part of Reading

Moore's conference in South Carolina." Carter records that, "In 1855, Elder James Turnage and Elder William Harris took a journey on horseback to petition the General Conference in South Carolina for permission to start a conference with their churches in North Carolina near and around Fayetteville and Dunn. Permission was granted and the churches met at Stoney Run on November 1, 1855, and organized the Cape Fear Conference named after the Cape Fear River that flows through that part of the state." Carter also notes that, "Three ministers from other Free Will Baptist connections were present in this first conference of the Cape Fear. One of them was Redding Moore, the founder of the South Carolina Conference which gave permission for the organization of the Cape Fear."

The documentation to support these claims consists of the Minutes of the Cape Fear Conference from its founding in 1855 until a temporary cessation of activity caused by the Civil War, and references in the history of the Stoney Run Church. Several points of interest raised by these claims must be addressed.

One of the three ministers from "Free Will Baptist connections" in attendance at the organizational meeting was Elder J. S. Carrow, representing the "Original Free Will Baptist Conference". This was presumably the North Carolina General Conference, and would seem to indicate some sort of dialogue and relationship between it and the Cape Fear Conference. By the late 1860's, it appears the Cape Fear Conference had aligned with the North Carolina General Conference. Why would churches located in North Carolina feel led to seek permission from the South Carolina General Conference in order to organize as a local conference? Perhaps it was the geographical location of the Cape Fear churches and the churches in South Carolina. It should be noted that there is no official mention of the request to the South Carolina General Conference in the Cape Fear minutes. That assertion is contained in the history of the Stoney Run Church, the first of the Cape Fear churches to be organized.

But, above and beyond that issue, how could Elders Turnage and Harris have contacted Redding Moore, and how could Moore have been at that first meeting, when he had died six years earlier? The record of evidence is convincing that Redding Moore had died in 1849. One answer would be that the records and recollections of the North Carolina churches are in error, and the events occurred prior to Moore's death in 1849. That, however, seems unlikely. Another more likely answer is that contact was made with a Rev. Moore seeking permission to organize the conference, but it was Samuel Moore, son of Redding Moore. Interestingly, every minister listed in the minutes of the first session is identified by first and last name, except the motion that "...Bro. Moore from South Carolina be invited to a seat with us." It is entirely possible then, and probable, that it was the younger Moore, and not his father, whom the brethren of the Cape Fear region held in such high esteem. Samuel Moore, by this time, was likely the pastor of Sand Hill Church, this being the only pastorate to which he can be connected, and the place of his burial. It is not a stretch of logic to assume that he had assumed the leadership mantle of his father.

Thus, the official minutes of the Cape Fear Conference must be weighed against the oral tradition of the Stoney Run Church, and both must be weighed against that which is known about Redding Moore. The result is a series of facts that must be acknowledged but cannot be fully understood.


The fates of Free Union and Fayetteville churches are not known. Shady Grove, Prospect and Elbethel " ... went with the faction that rejected the holiness and Pentecostal experience that came to the Cape Fear Conference at the turn of this century." Long Branch, Bethsaida and Stoney Run remain prominent churches in the Pentecostal Free Will Baptist movement.

#### GATEWAY CHRISTIAN COLLEGE BEGINS

Pastor Karl Sexton and Gateway Free Will Baptist Church announce the opening of **Gateway Christian College** in August of 2003 in Virginia Beach. GCC will provide a local-church structure maintaining a clear, unified purpose and direction as well as a fervent, revival type atmosphere. It is the commitment of Gateway, as a multi-ministry church, that the students will receive practical hands-on training in Christian service within a local-church setting.

Because the primary focus is to train and to produce faithful pastors, youth pastors, missionaries, Christian School teachers and administrators, GCC will begin the first year by offering undergraduate degrees in Bible, Missions, Sacred Music, Music Education, Elementary and Secondary Education, Religious Arts, Biblical Studies, as well as Certificate and Diploma Studies. Gateway's commitment is to provide a place where people will feel confident that they are receiving a quality and practical education properly preparing them for the ministry to which God has called them.

Dr. Bruce Barnes (Ph.D.) will serve as the college president. Serving with him in teaching ministry are seven professors who have either a M.A. or M.S. degree, three who are pursuing masters-level degrees, and three who are in the planning stages for doctorates.

Dr. Barnes states, "Students training for Christian ministry at Gateway College will be encouraged to have a personal walk with Christ and to fulfill the purpose of 2 Timothy 2:15, 'Study to shew thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." **Free Will Baptist Bible College** enrolled 339 students from 24 state (including 5 from South Carolina) and 8 foreign countries (Albania, Bahamas, Brazil, Canada, Japan, Russia, Spain, and Zimbabwe) for the 2003 fall semester. This is an increase of 5% over last year and a 21% increase since the fall of 2001. These 339 students are divided into 64 seniors, 61 juniors, 73 sophomorses, 134 freshmen, and 7 special students.

### The Students Bill of Rights

(From the August 2003 edition of "The Legal Alert" of the Christian Law Association. Used by permission)

Understanding what religious activities are allowed on public school campuses today can go a long way toward a more effective student witness. This summary should help you to be aware of your or your students' rights at school <a href="https://doi.org/10.21/20.21/

The Right to identify your Religious Beliefs through Signs and Symbols. Students are free to express their religious beliefs through signs and symbols.

The Right to talk about your Religious Beliefs on Campus. Freedom of speech is a fundamental right mandated in the Constitution and does not exclude the school yard.

<u>The Right to Distribute Religious literature on Campus</u>. Freedom of speech is a fundamental right mandated in the Constitution and does not exclude the school.

<u>The Right to Pray on Campus.</u> Students may pray alone or with others so long as it does not disrupt school activities or is not forced on others.

The Right to carry or study your Bible on campus. The Supreme Court has said that only state directed Bible reading is unconstitutional.

The Right to do research papers, speeches, and creative projects with Religious Themes. The First Amendment does not forbid all mention of religion in public school.

<u>The Right to be exempt.</u> Students may be exempt from activities and class content that contradict their Religious beliefs. <u>The Right to Celebrate or to study Religious Holidays on Campus.</u> Music, Art, Literature, and drama that have religious themes are permitted as part of the curriculum for school activities if presented in an objective manner as a traditional part of the cultural and religious heritage of the particular holiday.

<u>The Right to meet with School Officials</u>. The First Amendment to the Constitution forbids Congress to make any law that would restrict the right of the people to petition the Government (school officials).

The Equal Access Act specifically provides that if a public school receives federal funds and permits one or more non-Curriculum-related clubs to meet, student-initiated and student-led student Bible clubs must be permitted to meet in exactly the same manner, and with all of the same privileges. (Aug 03 Legal Alert).
