# STATE OFFICE RELOCATION COMMITTEE TO MEET THURSDAY, JULY 6, 2006.

The "Research and Ground Work" committee appointed by

the State Association during the 2006 State Meeting has concluded their preliminary work and evaluation of the proposed relocation of the SCFWB State Office and Christian Book Store to property adjacent to the Children's Home

and have called for a meeting of the Relocation Committee appointed by the State Association (Basically, the General Board) for Thursday, July 6, 2006 at the SCFWB Children's Home in Turbeville. This will be an open meeting but only committee members will be allowed to make motions or vote.

A "very rough" drawing of the new State Office Ministries Complex can be found on page 8 (This is simply to give people ideas of what is being considered. A formal drawing with proper proportions and including needed building information will be secured if the Relocation Committee declares the desire to relocate).

"Sean and Jill form part of the *Mediterranean Team* (M-Team) in southern France," Callaway said. "In addition to their ministries to the supporting churches, Sean will teach at FWBBC, and the Warrens will work with the students on campus."

Academic Dean Milton Fields said, "Sean taught Islam and

World Religions for us a few years ago. He will be teaching some of those again. Sean has an emphasis in Islam at the master's level."

Sean and Jill Warren are both FWBBC graduates. They have two children—Sophia and Lola. Sean completed a Master of Arts degree at Columbia International University. Jill is the daughter of Sandy and Dari Goodfellow. Sandy is director of plant operations at FWBBC, while Dari works with the Executive Office and coordinates the annual *Free Will Baptist Yearbook*.




#### **Dress Code**




# Relocation Information for presentation to the State Office Relocation Committee:

The "Research and Ground Work" committee for the relocation of the SCFWB State Office held their first meeting on Tuesday, May 16, 2006 at the SCFWB Home for Children in Turbeville. Present during that meeting were- SCFWB State Moderator, Rev. Sherwood Lee, Children's Home Board Chairman, Rev. Tim Hackett, Children's Home Director, Rev. Roy Roach, and SCFWB Executive Secretary, Rev Mike Jones.

After a time of questions and discussion it was decided that

- 1) Relocating the SCFWB State Office to the property adjacent to the SCFWB Home for Children would not present a problem in regards to the children or the ministry of the Children's Home.
- 2) The building plan for the new State Office Complex that included a gym was the best plan to pursue in order to benefit all areas of the SCFWB State Ministry.





Based on the information and input from these meetings and based on the following information the "Research and Ground Work" Committee recommends that a meeting of the "Relocation Committee" {General Board Members} specified in the motion made and passed at the 2006 SCFWB State Association be called for Thursday July 6, 2006 at 10:00am in the dining hall of the SCFWB Home for Children. (This meeting will be open to the public. A Meal will NOT be served since the Children's Home Staff and Children will be in another activity).

The Motion as made at the 2006 State Association Meeting

- 1) That a Committee be appointed at the 2006 State Association Meeting to determine the following:
- A) Is there a need or desire to consider selling the 1705 South Irby Street property and relocating the SCFWB State Office to the SCFWB Property in Turbeville, SC.
  - B) What price range could be expected from the sale of the present property at 1705 S.Irby St. .
- C) What would be the cost of a new State Office Building located on the SCFWB Property at the SCFWB Children's Home.
- 2) That this Committee consist of the SCFWB Executive Committee and the General Board member from each of the 6 state conferences.
- 3) That the expenses for the meetings of this committee (up to \$1000.00) be paid from the budget of the SCFWB State Office
- 4) That this committee report back with a recommendation to the 2007 meeting of the SCFWB State Association.
- 5) That the Executive Secretary, Bro. Mike Jones, the moderator, Bro. Sherwood Lee, and the Home for Children Board Chairman, Bro. Tim Hackett collaborate together in starting the research and ground work concerning the logistics of relocating the State Office to the Children's Home Property.

#### **Additional Information:**

1) The present State Office Building located at 1705 S. Irby Street in Florence has deteriorated to the place that upkeep is a problem and remodeling is considered unwise. Construction of a new building on the present property would involve money that is presently not available. This would also not be the best plan to enhance the overall ministries of the SCFWB State Association.



- 2) After contact with an Appraiser and with a Builder it is believed that the new State Office Ministries Complex including the Gym area can be built with the money received from the sale of the 1705 S. Irby St. Property. This is imperative since the SCFWB State Office does not presently have any money to build a new building and a loan of this magnitude is considered unwise.
- 3) The SCFWB Christian Book Store does most of its business via phone, fax, and internet. Relocating to Turbeville should not seriously impact the financial stability of the Book Store.
- 4) While moving from Florence will have an impact on the ease of contact with local area Pastors it is believed that the program that are being considered for the new State Office Ministries Complex will actually increase contact with all of the Ministers of the State. [Included in the plans is a class room area and the gym will allow room for big preaching and training meetings. If the other State Ministries use this facility as "dreamed" then visitors to the State Office will be a fairly regular event.]

In addition to the Primary Relocation Committee recommendation the following have added their support to the concept of relocating the State Office: Children's Home Board State Executive Committee State Youth Ministries Board

- 5) Building the new State Office Ministries Complex adjacent to the Children's Home will provide a gym area for use by the Children's Home as well as provide much needed space for their annual Children's Home day celebration. It will also increase first time visitors to the Home which we hope will prove a benefit to the ministry of the Children's Home.
- 6) The new State Office Ministries Complex would mean the State Youth Camp Ministry could formulate plans to use the availability of a gym and the 40 acres of land which comprise this property in planning for our own State Youth Camp (We presently spend over \$20,000 per year in rental fees to use other denominational camps. If we could one day have our own Youth Camp then we could use that money to improve the camping experience for our Youth as well as set up camp dates for the benefit of our youth instead of having to accept other camp ministries "left over times").
- 7) If the State Association were to so desire then the annual State Association meeting could be held at the State Office Ministries Complex. (Meals could be enjoyed in the Children's Home Dining area and, if the State Youth Ministry can build the dormitories they are dreaming of building, then adjacent lodging would also be available).

We stand at the door of the future of Free Will Baptists in South Carolina. The actions taken by this board (and eventually the State Association) will impact the work of Free Will Baptists in South Carolina for generations to come. We are faced with a choice. We can stay where we are or we can march into a future filled with promise and potential-...And they said, Let us rise up and build. So they strengthened their hands for this good work. Neh 2:18


The company that supplied our "800" phone number recently went bankrupt. We will wait until a decision is made to secure another. Right now the Book Store can be reached at (843) 662-8682



This is the Fellowship Building/Family Life Center recently constructed by Grace FWB Church of Lake City, SC at a cost of around \$250,000. The Fellowship Building front part contains a spacious kitchen, elegant rest rooms, and seating for around 200.

Pastor Carroll Bazen shared that several members of the Church have helped by contributing tables and chairs, kitchen equipment (resturant quality), and gym flooring and equipment.

This is the basic concept for the new State Office Complex except that the roof will be the same height over all the building and the foundation will be laid in such a way until a second story could be added to the Office part of the building if the need arose.

**FWBBC Sells Joelton Property-** NASHVILLE, TN—Free Will Baptist Bible College completed the sale of its 123-acre Joelton property for \$820,000 on June 14, according to President J. Matthew Pinson. The college purchased the land in 1994 for \$265,000 when it planned to relocate in Joelton.


President Pinson said, "We are delighted with the timely sale. Proceeds from the sale will be placed in a dedicated fund and held in reserve for the college's future relocation. Friends and supporters who purchased land in the college's 1994 *Claim the Land* campaign can be assured that their original investment will be used for its intended purpose—a new FWBBC campus."

The Board of Trustees voted in December 2005 to sell the Joelton property and authorized a six-month feasibility study on campus relocation after the college received an offer to purchase the Nashville campus.

Mark Johnson, who leads the college's feasibility study, said, "This is another positive step for FWBBC in our relocation study. We now continue the process of searching for land on which to build a new campus. We have an architectural firm in place to design the campus, and fundraising professionals at work surveying the denomination to help us determine support for a capital campaign."

Mr. Johnson confirmed that the Joelton property was purchased by Craighead Springs, LLC, a group of local businessmen.

FWBBC's Board of Trustees placed earlier relocation efforts to Joelton on hold in 2002 after site-development costs surged from \$2 million to more than \$5 million, and after two offers by prospective buyers purchase the Nashville campus were withdrawn.
