Minutes of the 73rd Annual SCFWB Association held at White Savannah FWB Church - February 26-27, 2015

The Theme of the annual meeting is - "Speaking the Truth in Love," Eph. 4:15

The meeting was opened with the hymn, "There Is Power In The Blood." Bro. Chris Todd offered prayer for the meeting.

Response by Bro. Danny Stone and introduction of the Thursday morning devotion speaker. Bro. Lanney Ard. Devotion from Eph. 4:15-16 on the subject, "Can You Hear Me Now?"

Bro. Tommy Hill called the Convention to order and introduced host pastor of White Savannah OFWB Church. Bro. Stephen Hyman welcomed the association to White Savannah OFWB.

Asst. Moderator, Bro. Danny Stone introduced the State Moderator, Bro. Sherwood Lee. Bro. Lee welcomed all to the SCFWB State meeting, offering opening comments and moved that we adopt a flexible program. MSC

Bro. Scott Ard gave the Partial Credentials Committee report. There are 6 conferences represented, 110 churches. All conferences have reported and all fees submitted, with all records in order. We recommend that the delegates be seated. We have 47 registered ministers, 9 delegates, 21 visitors, 4 national representatives, and 3 missionaries. Motion to seat the delegates. MSC

Bro. Lee recognized all visiting national representatives and missionaries.

Bro. Lee requested to have a motion from the General Board laid on the table. The

General Board moves that we allow deacons from local churches to be standing delegates. The deacons must be in good standing. This motion is laid on the table. MSC

SCFWB Ministries Report given by Bro. Tim Hackett as recorded in the Digest of Reports. Proposals: The following proposals are presented upon contingent of the final approval of the Pilgrim Holiness Denomination Executive and General Board to be held on Thursday, Feb. 25, 2015.

- 1. That we sell the FWB Children's Home to the Falcon Children's Home and Family Services for \$900,000 (\$450,000 upfront and the remaining \$450,000 over a 15 year period interest free at \$2500 a month).
- 2. That the Falcon Children's Home and Family Service be given first rights on all future sales of properties.
- 3. That SCFWB Association receive first right of purchase in the event the Falcon Children's Home and Family Service decide to sell.
- 4. That the funds from sale of property to be placed in FWB Foundation and future payments from sale to be added to existing funds (SCFWB Ministries Fund) (This is the 5% fund).

Friends of India: Report given by Bro. Mike Jones. Report details are available in Minutes booklet. The FOI budget is not part of the International Missions budget for Bro. Hanna. This is a way for us to help the work in India as a supplement to the International Missions program. The annual conference will begin March 19, 2015 and will be the largest gathering of FWB's that have every gathered for a conference anywhere in the world. As of Dec. 31, 2014 we have 1 missionary in India, Bro. Carlise Hanna, we have 21 ordained pastors in North & South India, 3 new pastors have been ordained in South India since 2014 making the total 24 ordained pastors. We have 125 evangelist church planters, we have 81 block buildings for worship, 27 temporary church buildings, 26 rented houses, and our total membership is 15,200 in our churches. Average Sunday morning worship is 11, 000 in attendance. Our evangelist church planters travel from village to village sharing the gospel. As people are won to the Lord, a pastor is called to lead the ministry in that village. Finances for the church planters are at a point where some of these men may have to be laid off. Their monthly salary is approximately \$75 monthly. This is a basic salary. Help must be provided to keep these preachers on the field working for the Lord.

Bro. Dr. Don Hanna gave a report and update on the mission work in India. We had 603 follow the Lord in believers baptism in 2014. People are responding to the gospel. We now have more villages requesting to hear the gospel than we have people to send. Two new church buildings in North India, #71 & #72 were just dedicated.

Board of Retirement report given by Bro. Ray Price. Bro. Price encourages all to participant in the retirement program. He discussed the four options available to those who choose to invest in the retirement program. Report received as given.


