A PRESIDENT'S MESSAGE

Tx. 2 Timm. 2:2

It is by the Grace and love of our Blessed Lord and Saviour, Jesus Christ that we have been given this privilege of meeting once again as the South Carolina State Association of the Original Free Will Baptist. Jesus has tarried prolonging His Glorious appearing when He shall call forth His Bride the Church for the great marriage Feast, thus giving the Bride (The Church) time to be ready to meet Him.

Reviewing briefly the work of the past Associational year, there are some note worthy accomplishments, for which we thank God and you who have been used by Him.

The spirit of cooperation and sympathetic understanding prevails among our brotherhood in greater proportions than ever before. We're united in purpose and prerogative and motivated by an impelling power that is certain to continue to bring forth evidence of the Blessings of our Lord. We're not wondering aimless about, but we have definite aims and objectives for which we're striving and to attain our goal we recognize the indispensable need for whole hearted cooperation. The secret for the wonderful success of the early Christian Church is revealed in the often repeated phrase found in Acts "of one accord."

They were of one accord as to the great Bible Doctrine. They were of one accord as to the program and purpose of the Church, that being the winning of lost Souls to Christ.

The chief business of the Church is to lead lost Souls to Christ that they might be saved from their sins and to be used of Him in the General spread of the Gospel. As important as other matters nothing is to have preeminence over this life stream, the fountain head, the power house, the everything to the believer. There is a danger of our putting our Church Program ahead of its very objective - Winning the lost - There is a danger of stressing organization and forgetting Salvation. There is danger

of driving Church attendance and failing to give those who attend the bread of life. We could be guilty of preaching giving to orphans, building funds, Educational program, Missions etc., and fail to teach that we're to worship God with our tithes and offerings and by our so doing these and other enterprises of the Church are to be maintained.

The world has never needed the Preaching of the Gospel more than today. It has never been that man, when brought to see the folly of His sinful and God-less living has discovered the need of God. Man kind is fast approaching such a time and the Church should be ready to meet that need with the Gospel of peace and hope for a troubled and hopeless world. The people are restless, comfortless, disturbed, distorted and wonderers and in need of Christ the Prince of Peace.

This is no time for the Church to compromise with the world, but to stand firm upon the principles of truth and righteousness. We're a "Peculiar People" a "Separated People" not a compromising, fence straddling, luke warm, lizzard type, do as you please, modernistic, pleasure loving people, ignorant of the New Birth, the Spirit-filled life, the power of God to transform, and make a new creature out of the drunkard, the harlot, the pleasure willed person. That's the kind of Salvation Free Will Baptist believe in. That's the kind of Salvation this old war torn, pleasure loving, doubting, hating, ungodly, world needs to hear about. What a horrible sin it is to keep it under a bushel, to fail to preach it, teach it, establish it in our town and villages, highways and byways to the lands of China, India, South America, Japan, and into all the world. Hearts are yearning for the Gospel as we believe and teach it.

The greatest threat to this Country is not the Atomic Bomb with its destructive qualities, but rather it is to be found in the false teachings that threatens and would destroy the bulwarks of our Christian Faith. When you have caused the youth to question the inspiration of the Bible, deny the Virgin birth, do away with the blood a-

tonement, the new birth, and other basic teachings of the word of God you have taken from that person just about everything that is worth while.

It is becoming evident that the Church that is to meet the spiritual need must remain spiritual, not make believe but by giving evidence of having been with the Lord. We're not opposed to some emotional manifestation which comes forth from a heart that overflows with inward joy, but we believe that there is an abiding blessing that will manifest itself even when the shouting has passed. Paul possessed it even in prison, on the stormy waters in the courts of prosecutions, Stephen found this Power when He was being stoned to death, John retained it when He was made to lay His head upon the chopping block there to die the death of a martyr.

Friends this is our day, thank God for it, may we go forward under the power of almighty God to lead souls to Christ, that they be not eternally lost.

As Moderator of this Association, I Prayerfully submit the following recommendations for your consideration.

I: I call upon Free Will Baptists of South Carolina to continue their fight against "public enemy number one" whiskey, wine and beer, to oppose it's being advertised and to support local option, or any other plan to hinder the sale and use.

II: To better unite our Ministers in our doctrine, our program and for spiritual development. I suggest a Minister's meeting for a period of one week each year, the meeting to be well planned for classes in Church Doctrine Church program and other matters that will contribute toward a more cooperative ministry for our Denomination in this State.

III: A well planned and directed Home Mission program, with the view of establishing Churches in communities not now being served by our Church. That capable ministers be secured with the view of making each meeting as near self-sustaining as possible, but the Pastors and Churches giving their support by attending as much as practical and giving financial help if and when

a Church is established.

At this time a very timely message was delivered by
 Rev. H. E. Powell on Free Will Baptist League Work.
 Rev. Powell used as his text Deut. 6:4-9, and Joshua 8:35,
 pointing out the great need of training the Youth of our
 Church.

Following Rev. Powell's message we had the Report
 of the State Convention of Womens Auxiliary, this re-
 port may be found at the close of these minutes.

It was moved and properly sustained that this As-
 sociation give to the Womens Auxiliary Convention space
 for their minutes without charge, this was passed upon
 favorably by the Association.

At this time Rev. Henry Melvin of The Free Will
 Baptist College in Nashville, Tenn., gave a good report on
 our Bible College.

Rev. Melvin pointed out that the College was in its
 eighth year, and at this time we have 66 men and women
 in school preparing for full-time service either here or on
 the foreign Fields. The Student body represented 15
 States and one foreign native from Cuba. At this time we
 have 43 young men and 23 young women enrolled.

In keeping with the great need of the Halls of Higher
 Learning, Rev. Melvin who is business manager of The
 Bible College assured the Association that the College
 was strictly fundamental in its teachings, also that the
 Doctrine of our Church was being taught.

At the opening of the next semester which opens in September, the College plans to open with a three year course, offering an extra year to all students who care to take it.

Rev. M. H. Mellette who is Chairman of the Free Will Baptist Orphanage Board of South Carolina presented the Orphanage. Brother Rollins Miles the Superintendent presented the children, who rendered a special program that was enjoyed by all. Rev. Mellette assured us that the Orphanage was striving to train our children in the fear and admonition of the Lord, also in Christian Service.

Following the fine program Brother Jessie Williams of the Eastern Conference presented the Orphanage with a check for \$100.00 in honor of Rev. Luther Smith. This fine contribution was given by Rev. Smith's daughter, Mrs. Ester S. Avent, and is to be used to purchase furniture for the matrons room.

At this time the Moderator presented to the Association a letter that was sent to this body by the First Baptist Church of Darlington, offering their facilities, church and Sunday School Department and offices for the National Association to be held in July, 1950, providing we can prevail upon that body to meet with us. A copy of the letter is printed below.

Darlington, S. C.
November 17, 1949

To the Association of Free Will Baptists of South Carolina. Greetings!

The Board of Deacons of the First Baptist Church, Darlington, S. C., in their monthly meeting, Nov. 6th last, authorized me to extend to your body the use of our Church building, offices, Sunday School building and all of its facilities, etc, for the week of July 18, 1950. It is our understanding that, at this time, you hope to have the National Association meeting with you.

We earnestly hope that you can prevail upon the National Association of Free Will Baptists to accept your in-

itation to meet with you at that time in Darlington. We, of Darlington, and especially our Church would be very pleased to have this body meeting in our city. We believe that the Spiritual contribution that such a meeting would have upon our city and State would be inestimable.

It is my personal belief that all the citizens of Darlington and its environs would do all in their power to help make such a meeting a large success. We earnestly hope that your State Association shall deem it wise to invite your National Association to meet with you, and us, in Darlington at the above mentioned time.

To The South Carolina State Association of Free Will Baptist. Greetings:

We the South Carolina Conference send Brother Walter Richburg and Brother Duffie Lynch as delegates to represent us in your Honorable body.

We have 21 Churches in our Conference with a membership of 2663. We have received 125 new members during this year. We also have received three Ordained Ministers, three Licensed Ministers, and have five Ministerial students in school in The Free Will Baptist College in Nashville, Tenn. We have 19 Ordained Ministers, Six Licensed Ministers, and Five Students.

All our Churches are in good working condition. There has been raised by our people during the Conference Year \$40,276.80 plus a large amount raised by Sunday School and Womens Auxiliary which would total approximately \$50,000.00, out of this amount our Pastors received \$12,157.00. We sent to Missions \$1,198.27 for Christian Education \$150.20, Orphanage \$5,856.03. Revivals \$3,229.98 the remainder was used for promotional improvements on our buildings. We have had one new Church organized in Manning, S. C. They have a membership of sixty members and have bought a building to worship in valued at \$5,000.00.

Be it Resolved:

That we at this Session of The State Association of Free Will Baptist of South Carolina, ask for the National Association of Free Will Baptists to convene with us in Darlington, S. C. at the First Baptist Church (Missionary) in 1951, and that the State Association arrange to take care of all advertising etc., that would be necessary for such a meeting.

At this time we called off for the Morning Service: The Message was brought by Rev. T. A. Williams. He used as his subject "Little Things". His Text was Exodus 4:2. "What is that in thine hand". His was a very timely message, pointing out that "Any Little Thing That God Has Is Much."

CONSTITUTION AND BY-LAWS OF THE SOUTH CAROLINA STATE ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS CONSTITUTION

Preamble: We, the officials, ministers and delegates, of this the South Carolina State Association of Original Free Will Baptists, while in session at Una Church, Spartanburg, South Carolina, November 13-14, 1946, do accept and adopt the foregoing constitution and by-laws:

Article One: This body shall be known henceforth as the South Carolina State Association of Original Free Will Baptists.

Article Two. It shall be the purpose of this organization to cooperate with the National Association in its efforts to elicit, combine, and direct the energies of the Free Will Baptist Church, for the promotion of Home and Foreign Missions, Christian Education, Sunday School, Free Will Baptist League and Ladies Auxiliary Work, and for the extension of the kingdom of God in general.

Article Three. Section One. This Association shall consist of delegates duly appointed or elected by the church or organization to represent, and ordained and licensed Free Will Baptist Ministers, who are of good repute in the Original Free Will Baptist Church, and who reside in South Carolina, or hold membership in, or pastor a church in South Carolina.

Section Two. Each Association or Conference, may represent in this Association on the basis of two delegates for each Association & Conference of one thousand members or less, and one additional delegate for each additional thousand members or fractions thereof.

Section Three. Any local church that desires to may send an additional delegate, provided said church sends a contribution for Association expenses of not less than \$5.00.

Article Four. This Association shall have an Executive Committee of five, composed of ordained ministers and lay members in good standing in the Association, one to be appointed by the Moderator each year for a five year term, to act officially in the event any case may arise in this Association, when, and only when it is deemed necessary or expedient for the best interest of the cause of the church in general.

Article Five. The officers of this Association shall be a president, first, second and third vice-presidents, a corresponding secretary, a recording secretary, and a reading clerk. Said reading clerk to take the place of the recording secretary in his absence and a treasurer.

Section Two. These officers are to be elected by the Association to serve a term of two years.

Article Six. All officers of this Association, all mem-

bers of its committees and boards, all its secretaries, missionaries, and agents appointed by the Association, or by any of its boards, shall be members of regular Free Will Baptist Organizations in South Carolina, cooperating with this Association.

Article Seven. All missionaries, teachers and Christian workers approved, appointed, or supported by this Association must be fundamental in their views of the Bible and its teaching, and in harmony with the doctrines of the Original Free Will Baptist Church. They must also give evidence of genuine Christian piety, for fervent zeal in the service of Christ, and of ability to do the work for which they are considered.

Article Eight. This Association shall hold its meetings annually on Thursday and Friday of the week between the second and third Sundays in November, beginning at 10:00 a. m., unless, or until, some change of the time of the year shall be thought best.

Article Nine. These Articles may be altered or amended at any regular session of the Association by a vote of two-thirds of the members present, providing the change is recommended at least one day before the vote is taken.

BY-LAWS OF THE ASSOCIATION

1.—A portion of the Scripture shall be read and prayer offered at the beginning of each morning and afternoon session of the Association, and prayer shall be offered at the close of each session.

This is to be done by the President, or someone appointed by him.

2.—The President or Vice President shall call the Association to order at the hour designated by the Program Committee.

When neither the President or the Vice-President is present, the Recording Secretary shall call the Association to order and a President Pro Tem shall be elected by the body, who shall preside for that session of the Association.

3.—It shall be the duty of the Recording Secretary to enroll the delegates of the Association who shall present themselves with proper evidence of their right to seats therein, and those enrolled by the Secretary shall compose the Association.

4.—Each organization represented in the Association shall send into the Association as large a contribution as they can from time to time. This money to be used to meet the expenses of the Association and to promote the work it undertakes.

5.—On the first day of the Association Meeting the President shall appoint a Resolution Committee to consist of three members, all resolutions not connected with the reports of boards and committees shall be referred to this committee, which shall report on all resolutions referred to it, with or without recommendation.

6.—The officers of the Association, the departmental Secretaries, the Executive Committee, and all boards shall be elected by the Association. All other committees may be either appointed by the President or elected by the body.

In the election of officers, boards, or committees, the votes may be by ballot if preferred, or by any other method agreed upon by the body.

7.—In the event of a standing Executive Committee, the members shall be elected for a term of five years except the first four elected, who shall serve a period of one, two, three and four years respectively.

8.—The duties of the Executive Committee shall be as follows: 1.—To act for the Association in matters that demand its consideration between the regular annual sessions of the Associations. 2.—To have oversight of arrangements for meetings of the Association with the authority to change, if necessary, the time and place of meeting. 3.—To fill vacancies in the Association that may be caused of death, resignation, etc., between the regular sessions of the Associations.

9.-It shall be required of all members of the Association to remain throughout the entire session, unless they are excused by a majority vote of the body.

10. Anyone desiring to speak shall rise and address the President, and shall wait until he is recognized before speaking further.

1.-The President shall not allow discussions that are unchristian in spirit and that tend to create envy and strife among the brethren, and anyone resenting the ruling of the President in such matters shall be liable to censure of body.

12.-No one shall be allowed to speak more than 15 minutes or more than twice on the same subject without permission of the body.

13.-It shall be the duty of the President to have his annual message so prepared and arranged that it can be handed to the Secretary for publication in the minutes of each session of the Association.

14.-The officers of this Association, except that of the Board of Trustees and the Executive Committee, shall be for a term of two years.

15.-These By-Laws may be altered at any regular session of the Association by a vote of two-thirds of the members present, providing the change is recommended at least one day before the vote is taken.
