PROCEEDINGS OF THE STATE ASSOCIATION

The Seventeenth Annual Association of the South Carolina Original Free Will Baptists convened November 12, 1959, at the High Point Church, Lancaster. During the Registration of ministers, delegates and visitors, Mr. Ben Staten from the Liberty Church asked for an opportunity to make a suggestion for the promotion of home missions in the state. He recommended that a box be placed in the vestibule of each church to receive voluntary offerings which would go toward helping new churches. This matter was submitted to the Association for consideration during the session.

The opening devotion was conducted by Rev. Roger Tripp. At the conclusion of a hymn, he read Rev. 1:10-19. Speaking on the subject "What To Expect In A Worship Service" he emphasized spiritual worship, spiritual vision, humility and obedience.

Rev. W. L. Jernigan, Moderator, called the Association to order and made some pertinent remarks concerning the responsibility of each one co-operating. The welcome address was given by Rev. A. F. Lawter. Rev. Leonard Williams gave the response. The moderator delivered his message on the subject "The High Cost of Loving". (CF Appendix I)

A motion was seconded and adopted *(MSA), that all temporary committees be appointed by the moderator, the following were appointed on the Finance Committee: Mr. Hoyt Smith, Mr. Pressley Langston, Mr. Herbert Collins.

The Churches and Associations reported by letter. There were 21 churches represented and three associational letters received. Eastern Conference did not report. Rev. L. A. Holliday inquired concerning the dues of each association. The matter was deferred until later discussion.

The visitors were recognized and given an opportunity to express words of greetings. Rev. M. L. Johnson, Mt. Olive, N. C.; Mrs. E. C. Howell, Sumter; Rev. and Mrs. Noah Brown, Charleston; Rev. Charles Brown, Pamplico; Mrs. R. E. Flowers, Pamplico; Rev. Bayless McDonald, Nashville, Tenn., were present. MSA that they be given a voice and all privileges except that of voting.

The Committee on Committees was appointed as follows:

Rev. Louis Holiday, Rev. Miller Mellette, Rev. Julius Vause.

A recess of ten minutes was taken before the worship service. Rev. W. L. Jernigan brought a message on the subject: "A More Excellent Sacrifice" based upon the scriptures: Gen. 4:8; Heb. 11:4; 12:18.

The Committee on Committees asked that they might assume the duties of a nominating committee rather than naming another nominating committee. Discussion ensued—A motion was seconded that the Committee on Committees also serve as a nominating committee. Before any decision was reached, a motion was adopted to recess for lunch.

*Note (MSA—Motion, Seconded, and Adopted)

The Association reassembled with the singing of a hymn. Rev. Bayless MacDonald gave the devotional message from II Tim. 3:15. Mr. MacDonald also reported on the progress of the Free Will Baptist Bible College. MSA to include the written report into the minutes. (cf: Appendix II)

A vote was taken on the motion discussed during the morning proceedings. It was adopted by a majority vote that the Committee on Committees act as a nominating committee.

The State Promotional Secretary, Rev. Reedy Saverance, gave a written report and it was adopted. (cf: Appendix III)

The idea presented by Mr. Ben Staten was again discussed. MSA that the idea be endorsed and referred to the State Home Mission Board to be included with their report.

MSA that the following constitutional amendments lay on the table until Friday. "Article III, Section 3" be amended to include the following sentence: "Each member association and quarterly meeting shall also be requested to send a representative fee of one dollar per church."

The Children's Home report was given by the Superintendent. MSA that we receive this report. (cf: Appendix IV)

A report on Christian Education was given by Rev. Norman Adams for Rev. W. B. Rogers. MSA to receive this report.

The State Superannuation report was given by Rev. Clarence Lambert. MSA (cf: Appendix V)

The Committee on Committees reported and it was adopted as follows:

Resolution Committee: Rev. L. A. Holliday, Rev. H. W. Richburg, Rev. Carl Shook.

Grievance Committee: Rev. Edison Kirby, Mr. Laverne Hanna, Mr. Tebe Hicks.

Obituary Committee: Rev. Rufus Coffey.

A report of Public Morals was given orally by Rev. M. H. Mellette. Rev. I. J. Blackwelder also gave an oral report of the Sunday School. The State Woman's Auxiliary report was read. MSA to receive this report as information and to print them in the minutes. (cf: Appendix X) MSA to recess until Friday morning.

The Thursday night worship service was conducted in the host church. After singing and testimonies, Rev. Noah Brown spoke on "Being Symetrical" from the scripture verse Hosea 7:8.

FRIDAY MORNING

With the joyful strains of a hymn, our hearts were lifted in worship. Rev. Joe Fort led in prayer and Rev. Ralph Staten was introduced. He brought an inspiring message on the subject "How Great Thou Art". After the devotion the visitors were recognized: Rev. Joe Fort, Ayden, N. C.; Rev. Burkette Raper, Mt. Olive, N. C.; Mrs. Alma McDonald, N. C.; Rev. Charles T. Dew, Conway; Rev. Clyde Cox, Caroleen, N. C.; Rev. Jerry Ballard, Columbia; Mrs. Herbert Collins, Beulah Church. MSA to extend them all privileges except that of voting.

Rev. Joe Fort spoke in behalf of the Free Will Baptist Press at Ayden, N. C. He gave information relative to the progress of the press and the new publications.

The minutes of the meeting on Thursday were read and adopted. The State Home Missions report was given by Rev. Fred Powers. MSA to receive this report and gave a rising vote of thanks for his service. (cf: Appendix VI)

There was no report from the Grievance Committee.

The progress, objectives and needs of the Mt. Olive Junior College were presented by the President, Rev. Burkette Raper. MSA to include the written portion into the minutes. (cf: Appendix VII)

After recess the Mission Service was conducted by Rev. L. A. Holliday. He reported that we were falling far short of our Quota in giving, and urged that we strive to increase our offerings to Foreign Missions. He read Isaiah 60:1-5 and brought a challenging message. The Association recessed for the lunch hour.

FRIDAY AFTERNOON

The devotions were given by Rev. Burkette Raper from Psalms 16:6-11 on the subject "A Goodly Heritage".

The final report of the Nominating Committee was given. The various officers were elected as designated by a star on pages two and three.

The following resolutions were adopted: (1) Be it resolved that the State Superannuation Director be bonded and that the expense be paid from the Superannuation treasury. (2) Be it resolved that the State Home Mission Director be bonded and that the bond be paid for out of their treasury. (3) Be it resolved that the State Association give time on the program for the Children's Home in the future. A discussion developed concerning the bonding of all treasurers. MSA that each one be bonded. Mr. Joe Lynch gave the Treasurer's report and the Poston Baggette Memorial Fund. MSA to receive the report. (cf: Appendix VIII)

A MSA to take from the table the constitutional amendment, and after due discussion MSA to adopt the change.

According to MSA the Credentials Committee is instructed to take care of the enrollment of delegates. They are to instruct our people how to make out reports and mail them along with their dues by November 1, each year to the committee.

A motion was adopted to give a rising vote of thanks for the hospitality, courtesy and royal entertainment extended to this body from the host church.

The 1960 Association was invited to meet with the Oak Grove Church near Conway. MSA that we accept this invitation.

After an announcement of the Spiritual Life Conference in February, MSA that delegates to the National Association be impaneled by the Moderator after arrival. A request was made for churches to purchase blocks to build a home at the Children's Home. Two thousand blocks were pledged.

The Conference adjourned and the congregation sang "God Be With You" in closing.

APPENDIX I

"THE HIGH COST OF LOVING"

Mark 12:30-31

There could be no question in the minds of any of us with respect to what it cost God to love us. Listen!, "For God so loved the world", wait a minute, underscore, and capitalize SO. Possibly eternity alone will reveal the value and effect of that little two letter word in John 3:16, the golden text of the Bible.

APPENDIX IX

RULES AND REGULATIONS FOR POSTON BAGGETT LOAN FUND

PURPOSE: The purpose of this Loan-Fund is to assist any worthy student entering full-time Christian service.

- 1. The applicant must be a member in good standing in a Free Will Baptist Church within our State Association.
- 2. The applicant must be recommended by his local church.
- 3. The assistance is available to any qualified person entering our Free Will Baptist Bible College or Mt. Olive Jr. College for any phase of full-time Christian service.
- 4. The loan shall be secured for a period of six (6) years by a Promisory Note signed by the applicant and co-signed by a person not in the immediate family who has sufficient real property of record to qualify as a surety for the payment of the principal amount of said note.
- 5. All loans approved shall be paid directly to the Free Will Baptist Bible College or Mt. Olive Jr. College.
- 6. The applicant must fill out the questionaire provided by the Board.
- 7. Less than a "C" average will render the applicant ineligible for further assistance.
- 8. These rules can be revised or amended by the South Carolina State Association of Free Will Baptists only.
