## Proceedings of the State Association

### THURSDAY MORNING

Pastors, delegates, and visitors assembled November 16, 1961, at 10:00 at the New Prospect Free Will Baptist Church. This Nineteenth Annual Association of the South Carolina Original Free Will Baptists began with the singing of the hymn "Love Lifted Me." The Rev. Paul Shehan read Scripture from Acts 12 and commented briefly on Peter's experience of deliverance from prison. The Rev. David Hutchinson led in prayer.

The Moderator, Rev. L. A. Holliday, called the association to order and gave some pertinent remarks relative to conducting the business in a Christian manner, and according to basic parliamentary procedure. The Rev. Hoyt Powell gave the welcome address, and the Rev. Edison Kirby gave the response.

The Moderator's message was given. (cf Appendix I)

The clerk proceeded to enroll the delegates from the various conferences and churches. Reports were received from each of the conferences except the S. C. Annual Conference. This was to be mailed in. A total of 40 churches represented with 25 from the S. C. Conference, 10 from the Central Conference, and 5 from the Eastern Conference.

The following visitors were recognized: Rev. Fred Kirby, Evangelist; Rev. Sherman Branch, Stanley, N. C.; Rev. Woodrow Byrd, Whiteville, N. C. Other lay visitors were present.

MSA\* that the Moderator appoint all committees for this session. MSA that the Nominating Committee be composed of representatives from each conference. MSA to recess ten minutes before the morning message.

The morning message was given by Rev. Roger Tripp on the subject "The Challenge of the New Church Year" from the Scripture verses II Peter 1:13, 3:1. He emphasized very forcefully the problems that confront our nation and church. The solution to our dilemma is found only in Christ, he pointed out. Our hearts were blessed through this servant of God. Following the message, we recessed for lunch which was served by the host church.

### THURSDAY AFTERNOON

The association reassembled after lunch and a hymn was sung. The devotional message was given by Rev. Jack Millwood. He spoke from Acts 15:28 on the subject "Necessary Things." The Moderator read the following appointments: Resolutions Committee: Mr. Ben Staten, Rev. L. H. Clayton, Mr. Tracy Williams, Rev. Paul Shehan; Nominating Committee: Rev. J. A. Hucks, Mr. Lexie Hutchinson, Rev. Arthur Lawter, Rev. Noah Brown.

The State Promotional Secretary, Rev. Reedy Saverance, gave his report. (cf Appendix II)

The Clerk read a letter from Rev. Homer Willis which sent his greetings, and expressed his appreciation for all contributions to the National Home Mission Board. Greetings from Mt. Olive Junior College and a verbal report was relayed to the body by the Moderator, who also stated that Dr. Burkette Raper was unable to attend.

A report of the Children's Home was given by the Superintendent, Rev. H. W. Richburg. MSA to receive this report, (cf Appendix III). Because of the splendid job that Bro. Richburg is doing at the Children's Home, a motion was adopted unanimously to recommend to the Board of Trustees that the salary of our superintendent be increased \$50 a month and retroactive to Oct. 1, 1961.

Rev. Charles Brown reported on the progress of the mission work in Che-raw. He requested trees to be given for their building. Two men offered trees.

A report of Christian Education was given by the Field Director, Rev. Kenneth Faison. MSA to adopt this report. (cf Appendix IV)

The State Sunday School Field Director, Mr. Lavern Hanna reported. MSA to accept this report. (cf Appendix V)

The Superannuation Field Director, Rev. Tyler Watford, reported on the need of doing more for this phase of work, and gave a financial report. MSA to accept this report. (cf Appendix VI)

Discussion developed concerning the State Home Mission Director's full time activities, and the basis of his employment. MSA to table discussion until the Home Mission Board reported.

A report of the Public Morals Committee was given by Rev. A. J. Blackwelder. MSA to accept this report. (cf Appendix VII)

MSA to lay on the table an amendment to Article VIII of the Constitution to change the time of meeting. MSA to stand in appreciation for the hospitality received from the host church during the day. MSA to recess until Friday morning.

### FRIDAY MORNING

The association opened with a song. Scripture from I Cor. 13 was read and prayer offered by Rev. Reedy Saverance. The Moderator expressed his appreciation for the unity and harmony that prevailed and expressed his desire that we continue in the same spirit throughout the day. Several late churches reported and the delegates were enrolled.

A report of the league work was given by Rev. Bennie Turner. MSA to receive this report as information. (cf Appendix VIII)

Mr. Joe Lynch gave the Treasurer's Report. MSA to receive it. (cf Appendix IX)

A report of the State Woman's Auxiliary work was read. MSA to receive this report as information. (cf Appendix XIV)

The State Home Mission report was given by Rev. Julius Vause. MSA to accept this report. (cf Appendix X)

MSA that the President of our State Association be made an ex-officio member of all boards.

The conference recessed before the morning mission service. Rev. Bob Rogers was in charge of this service. After giving his report as State Foreign Mission Director (cf Appendix XI), he led the body in prayer for all of our missionaries. Rev. Fred Hersey, our returned missionary from Japan, was introduced. He brought a stirring message on the thought of our being an instrument and voice of God to proclaim the message of salvation to all the world. A missionary offering was taken in the amount of \$62. The conference recessed for lunch, which was supplied by several churches in the conference.

#### FRIDAY AFTERNOON

After the singing of a hymn, Rev. Dean Dobbs gave some devotional thoughts from Psalm 126:5, 6.

MSA to receive the Foreign Mission Report. MSA to authorize the Foreign Mission Director to pay his actual expenses in promoting Foreign Mission work within the state.

MSA that all state officers, board members, and anyone acting in official capacity for the state association be paid six cents per mile for expense.

The Resolutions Committee reported. Each resolution was read and acted on individually. One resolution was referred back to the committee for clarity of expression. (cf Appendix XII)

The Home Mission Board reported. MSA to adopt this report. (cf Appendix XIII)

The Finance Committee reported that \$476 had been received at this association. MSA to receive this report.

The Nominating Committee read the nominations. MSA to receive this report, and vote on each one individually. They were elected as indicated by a star in the Directory. MSA to accept the resignation of Rev. Julius Vause from the Board of Trustees at the Children's Home with a standing vote of appreciation. Mr. Creighton Gibbons was elected to fill this unexpired term.

The revised report of the Resolutions Committee was read and adopted. MSA that the program next year be completed and published in the denominational papers ahead of the meeting. MSA to give a rising vote of thanks for the hospitality received in the host church and in this conference.

A motion was adopted that the clerk be empowered to panel the delegates to the National Association when it meets in Nashville in July, 1962.

### APPENDIX I

#### MODERATOR'S MESSAGE

Never before in my entire ministry have I come before a congregation with a more sincere desire to speak the right words. My prayer is Psalm 19:4 "Let the words of my mouth and the meditations of my heart, be acceptable in thy sight, O Lord, my strength and my Redeemer."

Never before in my entire ministry have I faced an assignment whose responsibilities rested more heavily upon my heart than this nineteenth session of the State Association of Original Free Will Baptist of South Carolina. The year of our Lord nineteen hundred sixty-one is a crucial year among Free Will Baptist everywhere. I believe that when a Christian faces a problem he should pray and not panic. Now I do not stand here before you alone. I have the witness because of the prayerful support given me by you who are present and others that have this meeting at heart. You have prayed for this meeting and upon this initial move we're in agreement. Both you and I have prayed to God — the only true and living Lord. All true praying seeks the will of the Lord Jesus to be done.

Eph. 6:6, 7 "Not with eye service, as men pleasers; but as the servants of Christ, doing the will of God from the heart." V. 7, "With good will doing service, as unto the Lord, and not to men."

To me it seems a short nineteen years since that first meeting held with Whitney Church, Whitney Village, Spartanburg. The date was Sept. 10, 1943. The organization had been set up at a previous meeting held a few months earlier. This meeting was held in Darlington with the Darlington Church. At this first regular session held at Whitney Church, the minutes list five associations having represented and seventeen churches. Among those I remember that we had one Indian, the Rev. D. O. Oxeudine. He represented

the St. Anna Association. This was a small beginning if you determine its size by the figures I have given you. From the last paragraph of my brief address to that first meeting I quote, "We believe that with our interest and efforts united we shall 'GO FORWARD' in the Name of the Lord," (The 1943 Minutes of S. C. State Association).

You have been kind to me in giving me everything you could have given anyone. When I think of your kindnesses it always calls for my very best. When you gave me this assignment 19 years ago I accepted it as your servant under God. Today I feel as I did then. I humbly accept my responsibilities to my church here in the state of my nativity. With the exception of my college years I have lived here. I love my church—I am happy when I think of her growth and I am unhappy when I see attempts to remove the ancient landmarks. I am satisfied with its doctrines and discipline. I am dissatisfied with the disturbances and dissensions. If I have appeared to be unkind — determined and uncompromising, it is due to my love and loyalty to the church that has blessed my life through its builder Jesus Christ, our Lord and Saviour. It is my sincere belief that we've generally agreed upon these matters I have touched upon. If I am correct in this assumption, we're ready to join hands and hearts and move forward together.

Ahead of us we see a hill — they call it Golgotha. Upon this hill is a cross. Nailed to this cross is the Son of God, the Saviour of the world. We hear Him agonize. As we draw nearer we see the blood dripping from His body, and splattering on the ground beneath. LOOK at those eyes—they're focused on us. What is meant by this look of love and understanding?

Can it be that this "Holy One," This One "Altogether Lovely," This One so good—yes, can it be that He must die? Yes, it's true. We remember He said when He was yet with us that He must needs suffer for all mankind. **What Love** — indescribable — unlimited — limitless love. **What Grace** — unmerited — unlimited and unwanted. **What Mercy** — Full and complete. Oh, my brother ministers, delegates, and visitors. Lift up your heads and behold the Christ of Calvary.

**RULES THAT GOVERN THE POSTON-BAGGETTE MEMORIAL FUND**

1. The applicant must be a member in good standing in a Free Will Baptist Church within our State Association.
2. The applicant must be recommended by his local church for a loan, with a statement that he/she has been unable to secure assistance from any other source.

3. The assistance is available to any qualified person entering our Free Will Baptist Bible College or Mount Olive Junior College for any phase of full-time Christian service.
4. (a) The loan will be secured by a promissory note signed by the applicant and co-signed by his/her church or a person who has sufficient collateral to guarantee the collection of said note. (b) The loan may be issued for a period of six years maximum, and at the option of the board may be extended for a period of one year. If the applicant fails to comply with the rules and regulations, the note will become due within one year from the time of default. (c) No interest shall be charged on a loan as long as the applicant is a student; but thereafter at the rate of 4% annually until the loan is paid in full. (d) A payment on this loan shall be expected within sixty days after withdrawal or completion from school, and equal monthly payments thereafter until the loan is paid in full.
5. All loans that are approved shall be paid directly to the Free Will Baptist Bible College or Mount Olive Junior College.
6. The applicant must fill out the questionnaire provided by the Board.
7. Less than "C" average will render applicant ineligible for further assistance.
8. These rules can be revised or amended by the South Carolina State Association of Free Will Baptists only.

First Church, Florence (52.07); Mt. Elon (\$6.12); Horse Branch (\$14.17); Little Star, West Side, one individual and the S. C. District League Convention gave \$150.00 to the Expansion Campaign. One hundred twenty-five dollars is still needed to meet our quota of \$275.00.

The highlight of our State League work is the Youth Camp each year at Cheraw. Last summer we had more than 200 young people to attend. This is a fruitful ministry that is producing eternal results.
