Proceedings of the State Association

THURSDAY MORNING, NOVEMBER 17, 1966

The twenty-fourth Annual Session of the South Carolina State Association of Original Free Will Baptists convened at Horse Branch Free Will Baptist Church on November 17, 1966.

The meeting was opened by the singing of "Nothing But The Blood". Rev. Ralph Osborne led the singing, Rev. Sherwood Lee was the organist and Mrs. Edra Saverance was the pianist. Rev. Tommy Godley brought the devotional thought, from Joshua 1:1-9, emphasizing the need of Strength and Courage as we serve the Lord.

The moderator, Rev. Robert Edwards, called the Association to order. The welcome was given by Mr. Euston Green, a member of the host Church. The assistant moderator, Bro. Jack Millwood, responded to the welcome and introduced the moderator, Bro. Robert Edwards, who then brought his message to the body (see Appendix I). He closed in prayer.

M. S. C. to adopt the printed program as corrected by the moderator as our agenda, and that we adhere to it as close as possible.

The following were appointed on the Committee on Committees: Chairman, Rev. Dennis Wiggs, Rev. Donnie Seay, Rev. Paul Reid, Rev. Lloyd Gore and Rev. Ned Pattillo.

The following visitors were recognized and welcomed: Rev. Roy Rikard, Cramerton, N. C., Rev. W. H. Calvert, Gastonia, N. C., and Mrs. Beatrice Parker, Selma, N. C.

The moderator declared a fifteen minute recess.

The Morning Worship hour began by the congregation singing "Sunlight" followed by prayer by Rev. W. H. Calvert. Bro. Jack Millwood introduced the speaker for the morning, Rev. Roy Rikard from Cramerton, N. C. Bro. Rikard was presently serving as pastor of the Cramerton F. W. B. Church as well as the president of Piedmont Bible Institute. Bro. Rikard spoke to us from II Tim. 4:1-19. He emphasized the importance of preaching the "Word" concerning (1) Holiness (2) Apostasy (3) Feet Washing and (4) The Second Coming of Christ.

The Report of the Committee on Committees was adopted by motion (see Appendix II).

The Report of the Credentials Committee was adopted by motion (see Appendix III).

M. S. C. that all resolutions that pertained to the spending of money come through the finance committee to the body.

Bro. Malone Cobb dismissed us in prayer and asked the blessing on the food. Lunch was provided by the host church.

THURSDAY AFTERNOON, NOVEMBER 17, 1966

The afternoon session was opened by the congregation singing "Leaning on The Everlasting Arms" followed by the devotional thought by Rev. Paul Reid from Acts 16:25-31. Bro. Paul Sheehan closed in prayer.

M. S. C. to receive the Report of the State Promotional Secretary as information and to enter it into the minutes (see Appendix IV).

The Report of the Children's Home was given by Rev. Paul Sheehan and received by motion (see Appendix V).

The Moderator recognized the following visiting ministers: Rev. Paul Ketteman from Nashville, Tenn.

M. S. C. to receive the Report of the Committee on the Conference and Church report blanks. M. S. C. to amend the motion to the effect that the clerk be instructed to make sure that the report blanks supply all the information necessary in order to enable him to make out an accurate report to the National Association (see Appendix VI).

M. S.C. for the Moderator to appoint a committee to investigate the work of the boards and committees of the State Association and to report at the next session of the State Association. Rev. Dennis Wiggs (S. C. Conference-Chairman), Rev. Hoyt Powell (Eastern Conference) and Rev. Jack Millwood (Beaver Creek Association) were appointed to this committee.

Bro. Paul Ketteman gave an oral report of the Free Will Baptist Bible College in Nashville, Tenn. M. S. C. to receive the report as information.

The Report of The Board of Christian Education was presented by Rev. Paul Reid and adopted by Motion (see Appendix VII).

The Report of the C. T. S. Board was given by Bro. Dennis Wiggs and received by motion as information (see Appendix VIII).

The Report of The State Woman's Auxiliary was given by Mrs. Paul Sheehan and received as information (see Appendix IX).

After several announcements we adjourned until 9:30 A. M. Friday morning, November 18, 1966. We were dismissed in prayer by Bro. Dennis Wiggs.

FRIDAY MORNING, NOVEMBER 18, 1966

The second day's session of the Twenty-fourth Annual Session of the South Carolina State Association of Original Free Will Baptists opened by the congregation singing "When I See The Blood". Rev. Robert Edwards, the Moderator, presided.

The devotion was brought by Rev. Liston Williams from Luke 17:11. He emphasized the truth that we as Christians need to be thankful for all the blessings that God has given us. His subject was "Where are the Nine?" He closed in prayer.

The following visitors were recognized and welcomed: Rev. Reford Wilson, Rev. Sam Johnson, Rev. Harold Harrison and Mrs. Harrison, Rev. Mark Vandivort all from Nashville, Tenn., and Rev. Galen Dunbar from Beaufort, N. C.

The Report and Recommendations of the Board of Superannuation was given by Rev. William Sealy. M. S. C. to adopt the report and the recommendations (see Appendix X).

Bro. Sam Johnson, Director of the National Office of the Church Training Service, gave a report of the C. T. S. work. M. S. C. to receive the report as information.

M. S. C. to accept the report of the Public Morals Committee (see Appendix XI). M. S. C. to amend the motion by deleting the word "abuse" and substituting the word "use" and deleting the words "alcoholic beverages" and substituting the word "alcohol," in the report.

The Report of The State Sunday School Board was given by Bro. Ralph Osborne and received by motion (see Appendix XII).

Bro. Mark Vandivort gave a report of the National Home Missions Board. M. S. C. to receive the report as information.

The Moderator declared a Ten Minute recess.

The Morning Worship service began by the singing of "Rescue the Perishing". Bro. J. A. Hucks led us in prayer. After Bro. Reedy Saverance rendered a beautiful number, "Harvest Time," Bro. Reford Wilson gave us an oral report of the National Foreign Missions Program. After his report he brought us the morning message from Acts 1:8. He emphasized the task of the Church to evangelize the world. It is our responsibility to get the gospel to the ends of the earth. Bro. Paul Ketteman closed in prayer. At the close of the message an offering was received for Foreign Missions which was to be applied to the Sherwood Lee account (\$67.60).

Various announcements were made and the body recessed for the noon hour. Lunch was provided by the Host church. We were dismised in prayer by Bro. Harold Harrison who also asked the blessing on the food.

FRIDAY AFTERNOON, NOVEMBER 18, 1966

The afternoon session opened by the singing of "He Keeps Me Singing". Bro. J. A. Hucks was in charge of the devotions from Acts 2:1-6. He emphasized the need of being empowered by the Holy Spirit in order to be effective in Christian Service. He closed in prayer.

The Treasurer's Report was given by Brother Joe Lynch. M. S. C. to receive the report (see Appendix XIII).

The Finance Committee gave its report and it was received by motion (see Appendix XIV).

M. S. C. to request that each Quarterly meeting send one dollar per church to the State Association this year. This money is to be sent to Bro. Joe Lynch, Rt. 1, Scranton, S. C.

M. S. C. that the Clerk write all the churches that didn't represent this year and to make known to them that the State Association was in debt and to graciously request them to send in their rpresentation fee of ten dollars. This money is to be sent to Bro. Joe Lynch, Route 1, Scranton, S. C.

The Report of the Resolution Committee was given by Rev. L. H. Clayton and the resolutions adopted by motion (see Appendix XV).

M. S. C. for the Moderator to appoint a committee to meet with the Beaver Creek Association to discuss the possibilities of a State Association Youth Camp. Rev. Hoyt Powell, Rev. Dennis Wiggs, Rev. Fred Kirby, Rev. Lonnie Jones and Mr. L. N. Coker were appointed to this committee.

Mrs. Sheehan, Mrs. Owens, Mr. Allen Baxley, Mrs. Lloyd Gore and Mr. Earl Hendrix were appointed by motion to serve as delegates to the National

Association with the Moderator having the right to appoint alternates if they are not present.

The Nominating Committee gave its report and it was accepted by motion and voted on item by item. (For a list of the Officers see the Directory of the State Associational Officers on pages 2 and 3.)

- M. S. C. to receive an offering to purchase a "Show and Tell" from the National Sunday School Department for the Children's Home.
- M. S. C. to give to the Host Church a rising vote of thanks for their hospitality.

After a few remarks and announcements the session was adjourned in prayer, led by Rev. Paul Sheehan.

The Twenty-fifth Annual Session of The S. C. State Association of Original Free Will Baptists will convene with the Arcadia Free Will Baptist Church, Arcadia, S. C., on November 16, 17, 1967.

APPENDICES

APPENDIX I

THE DIVINE COMPULSION

Ps. 126:5-6

Intro. I would like for us to look at our text and see if we can find a reason for the unconcerned, unproductive, unchristian attitudes existing in our churches today. Let us analyze the text:

- I. A DIVINE COMPULSION. "He that goeth forth."
- 1. This is not a voluntary journey, nor one based on one's own judgement. This is a journey directly determined and commanded by God. It is interesting to note several in the Bible who thus "Go forth."
- a) Abraham Gen. 12:1,2,4a. All Civilization has been affected by this journey. (1) Nation Israel born of this, (2) Marvelous O. T. history written as consequence of this, (3) Virgin birth of Christ a product of this journey, (4) The process of Christian civilization with its influences on all world affairs stemmed from this journey. How meaningful then the phrase "He that goeth forth."
- b) Moses "Going forth" as recorded in Heb. 11:24-27 shows the great influence of "Going forth" as directed by God. (1) He went forth not only to escape the vanity of the King's palace, but also to create a Nation that should play a conspicious part in World History. (2) Most young men plan to "go forth" from their homes when they reach adulthood, but so few "go forth" under Divine Compulsion to live a life Divinely-Empowered. That's why the average man is a failure. That's why few men are a success. How about YOU?
- c) David went forth to take brothers news of home and some home cooking, but actually he went because God commanded it, or directed it. The consequence was Death of Goliath, defeat of Philistines, establishment of Davidic Kingdom, and finally the coming of Christ in David's lineage.

d) In N. T. John Baptist went forth to herald the coming of Christ. Peter stood forth at Pentecost to be spokesman for God. Paul went forth from fellowship with the Scribes and Pharisees to be first agent of Jesus of Nazareth to gentiles, Philip as His Evangelist, Stephen as His Marytr, and all the apostles as His sent ones. (1) Going forth on one's own option may mean little or nothing, but on a Divine errand at God's command, that outshines all other honor for Christians. (e) Yet so few of the multiplied Christians are ready to ask, "Lord, what will Thou have me to do?" and to go forth on the Divine errand with the promise of Divine power to accomplish the task.

II. A HUMAN COMPASSION. "And Weepeth."

- 1. This is not a weeping over personal sin! These are intercessory tears; weeping as Christ wept over a ruined and wretched world. We remember how He sat on a hill that overlooked Jerusalem, His heart breaking as He cried, "O! Jerusalem, Jerusalem."
- 2. Christ was not a deeply emotional person. On another occasion He wept, at the tomb of Lazarus. Here He remembered that, "Sin when it is finished bringeth forth death." That should cause Christians to weep as they see the sinfulness of man. 3. Here churches fail. Sin no longer STINKS. It is dressed up.
- 4. No burden because of spiritual droughts in church services. No conversions. Are YOU concerned? 5. Moody went to England with little results till he came to the place where two women had been praying for years that such an Evangelist might come. Results were so astounding that Moody asked those who wanted to be saved to stand a second time, because he could not believe his own eyes.
- 6. A burden of interest caused 120 to stay on their knees for ten days, Pentecost burst forth and thousands were saved.
- 7. The church is dry-eyed now. This is one reason for so few converts. When our concern has deepened, and we spend sleepless nights praying for sinners, then results come.
- 8. We live in the midst of crowds, we do not see them as they are. They are hell-bound sinners, men and women whose destiny is doomed. Two-thirds of the people that pass you are lost; in sin, sorrow, and distress. Sheep without a Shepherd. Do YOU care? We go to bed at night and never think of them. In the morning we forget them again. OH, God, that the care of souls might come upon the WHOLE CHURCH. It comes upon so few.
- 9. Ask the Hannas, the Cronks, and Miss Wilson why they are in India? They care for souls. Forget themselves. Live in filth, etc., without modern conveniences.
- 10. Ask any of our other Missionaries why they are serving God in their particular locations and they will tell you that they care for souls.
- 11. I believe in Foreign Missions as you well know, but Brethren and Sisters, are we burdened? Have we shed any tears over souls dying at our elbows without Christ as Saviour? Are we concerned over souls in our community or church?

III. AN IMPORTANT POSSESSION. Bearing precious seed."

1. What is this precious seed? Jesus said in Luke 8:11 "The seed is the Word of God."

- 2. That's what's wrong. We haven't had enough of THE WORD. Concerning Its sowing we have great and precious promises. Isaiah 55:10-11.
 - 3. Concerning this Word, Paul told Timothy, "Preach the Word."
- 4. No such promise is made in Socialism, Communism, Philosophy, or Psychology.
- IV. A TRIUMPHANT RETURN. "He shall doubtlessly come again with rejoicing, bringing his sheaves with him."
- 1. The man that proclaims The Word of God as described herein shall reap.
- 2. Those who have no questions whatever as to the Authority of the Bible are the ones that come with rejoicing and sheaves.
- 3. But you say, "Lord, I am so small, what can I do?" Jesus wants us out there in the world loking for those who are lost.
 - 4. Will you really give yourself to Him to reach those who are lost?

CHURCH TRAINING SERVICE

Most of our churches have CTS on Sunday evenings preceding the Evening Worship Service. Some churches also have monthly CTS programs in the church or in the homes.

The purpose of the Church Training Service is "that part of a Free Will Baptist Church specifically dedicated to the task of providing an adequate program of Christian training to the total church family in order that each member may come to know Christ as Saviour and Lord and be able to make Him known to others in an effective manner."

The CTS materials are offered by the Board of Church Training Service of the National Association of Free Will Baptists. Mr. Samuel Johnson, director, and his staff have produced excellent materials for our churches to use to provide Christian training for every age of our Free Will Baptist family. All of our churches are encouraged to provide this training for our people. Sample materials can be secured from the office in Nashville, Tennessee (P. O. Box 1088).

The State Church Training Service convened at Beulah Church April 16, 1966, for a good day of spiritual challenge and Bible training. Missionary to Brazil, Bobby Poole, was the visiting speaker. APPENDIX X

SUPERANNUATION REPORT

The Superannuation Board would like to submit the following report and recommendation.

During the last twelve months the Director has visited twice in each of the four conferences that constitute this body. One meeting was on behalf of the minister's Blue Cross, Blue Shield group and one for Superannuation work in general. We have also added three men in our retirement assistance program even though one of them has asked that his assistance be withheld until further notice.

The Superannuation Board has met four times since the last meeting of this body. In these meetings several things were discussed. One of the things discussed was a constitution to govern its operation. The resolution as adopted by the Board is hereby submitted to this body for action.

- I. It shall be the duty of the Superannuation Board member from each conference in conjunction with the State Director to promote the cause of Superannuation in his respective conference.
- II. The Superannuation Board is to supervise and distribute retirement and other assistance, as approved by the Board, to the ministry of the S. C. State Association of F. W. Baptists.
- III. The State Director will be the treasurer of Superannuation funds. He will serve as group leader for the hospitalization plan and make periodic reports to the pastors and churches of the State Association.
- IV. The Director is authorized to pay Board members seven (7) cents per mile for travel expense incurred in connection with Superannuation promotion and Board meetings. The Director is to keep records of such reimbursements and shall show same in his annual report to the State Association.
- V. The Director is authorized to pay himself seven (7) cents per mile for travel expense incurred with promotion of Superannuation, insurance supervision, and Board meetings. He is also authorized to reimburse himself for expense incurred in connection with the office operation such as: postage, telephone calls, office supplies, and labor (help) in preparation of reports.
- VI. The Board is to meet at least twice each Associational year, said meetings to be held in April and November. The November meeting to be held during the State Association meeting. The April meeting at a place and date convenient to most of the men involved. Other meetings may be called by the State Director or 75% of the Board members if the need arises.
- VII. The Board member, whose term expires first, will be considered the chairman of the Board.
- VIII. This constitution may be amended by the Superannuation Board in any regular Board meeting but the changes must be approved in the next session of the state association.

The above constitution shall be included in the Director's annual report to the State Association in November 1966 with a recommendation, to the body, that it be adopted to govern the operation of the Superannuation Board and the Field (State) Director of Superannuation.

APPENDIX XI

PUBLIC MORALS COMMITTEE REPORT

ALCOHOL

Alcohol is a narcotic as are ether and chloroform. Alcohol has toxic or poisonous effects whenever used. These effects are chiefly, if not exclusively, due to action on the brain and other parts of the central nervous system and are mild or severe, acute or chronic, according to the amount of alcohol consumed and the percentage circulating at any particular time in the blood.

What the community gets in taxes on the beverage alcohol industry and retail trade does not nearly meet the costs of illness, death, unemployment, accident, crime, and mental disease which are the result of the use of alcohol and for which the community must pay.

The expenditure for alcohol brings to society no benefits but a multitude of individual and collective misfortunes. Social progress, as in the case of individual bodily and mental performance, is obstructed and rendered inferior by the beverage alcohol as now consumed in the United States.

COMMUNISM

Communism, in the sense that we understand the word today in the world round about us, was anti-religious when it began to function in Russia The communists were definitely in the minority in Russia when they took over by force and bloodshed. They were able to do this because the Christian people were fast asleep.

The United States Government Report No. 2290, on page 52 says: "The Communist Party and Soviet government have done everything in their power since 1917 to mock, destroy, and outlaw religion. Churches have been pulled down, or turned into clubs, religious shrines despoiled, burial grounds desecrated; and the clergy persecuted and slain. The denial of religious liberty and the wiping out of all religions are an important part of the communist program."

The bold facts make us admit that communism is truly anti-Christian and atheistic. Our beloved country is in the eleventh hour. The world is being overrun by red radicals; they are attempting to seize power in the United States. Only a return to genuine Christianity with Christ as God and Savior in the center of all our thoughts and actions can save this country and check the resing tide of atheism and radicalism in America. Pray to God before it is too late! Take an active Christian part in your government.

SOCIAL DANCING IN THE PUBLIC SCHOOLS

The fact that social dancing is being taught in the public school systems of our cities is creating a problem for many of our young people who want to live the purest and cleanest lives for their Lord. The social dance is one of the contributing factors to our widespread evil of juvenile delinquency, and the young people are therefore urged to avoid this pastime. While the modern dance did not exist in Jesus' time, we believe the following Bible passages underscore the danger inherent in it. I John 2:15-17; I Cor. 6:19; I Cor. 10:31; Romans 12:2; Matthew 5:28; Matthew 6:13. All parents who so desire may have their children excused from the school classes in social dancing. We urge them to do so.

We recommend to Free Will Baptists that they strongly oppose such sinful habits, customs, pleasures, sports and worldiness such as leud pictures and literature, immodest clothes, Sunday sports, card playing, Communism, dancing and the use of alcohol of all kinds, except when prescribed as medicine.

CONSTITUTION AND BY-LAWS Of the South Carolina State Association Of Original Free Will Baptists

PREAMBLE: We, the officials, ministers and delegates of this the South Carolina State Association of Original Free Will Baptists, while in session at Una Church, Spartanburg, South Carolina, November 13, 14, 1946, do accept and adopt the foregoing constitution and by-laws.

ARTICLE ONE: This body shall be known henceforth as the South Carolina State Association of Original Free Will Baptists.

ARTICLE TWO: It shall be the purpose of this organization to cooperate with the National Association in its efforts to elicit, combine, and direct the energies of the Free Will Baptist church, for the promotion of home and foreign missions, Christian education, Sunday school, Free Will Baptist C. T. S., superannuation, and woman's auxiliary work and for the extension of the Kingdom of God in general.

ARTICLE THREE:

SECTION ONE: This association shall consist of delegates duly appointed or elected by the church or organizations to represent, and ordain and license Free Will Baptist ministers, who are of good repute in the Original Free Will Baptist Church, and who reside in South Carolina, or hold membership in, or pastor a church in South Carolina.

SECTION TWO: Each annual association and quarterly conference may represent in this association on the basis of two delegates for each association or quarterly conference of one thousand members or less, and one delegate for each additional thousand members or fractions thereof.

SECTION THREE: Any local church that desires may send an additional delegate, and each church shall send a contribution of \$10.00 or more. Each member association and quarterly meeting shall also be requested to send a representative fee of one dollar per church.

ARTICLE FOUR: This association shall have an executive board of five members: Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer; composed of ordained ministers or lay members, in good standing in the association, to act officially in the event any case may arise in this association, when and only when it is deemed necessary or expedient for the best interest of the cause of the church in general.

ARTICLE FIVE: The officers of this association shall be a Moderator Assistant Moderator, Clerk, Assistant Clerk, and Treasurer.

ARTICLE SIX: All officers of this association, all members of its committees and boards, all its secretaries, missionaries, and agents appointed by the association or by any of its boards, shall be members of regular Free

Will Baptist organizations in South Carolina and cooperating with this association.

ARTICLE SEVEN: All missionaries, teachers and Christian workers approved, appointed, or supported by this association must be fundamental in their views of the Bible and its teachings, and in harmony with the doctrines of the Original Free Will Baptist Church. They must also give evidence of genuine Christian piety, for fervent zeal in the service of Christ, and of ability to do the work for which they are considered.

ARTICLE EIGHT: This association shall hold its meeting annually on Thursday and Friday of the week between the second and the third Sundays in November, beginning at 10:00 a. m., unless, or until, some change of the time of the year shall be thought best.

ARTICLE NINE: Articles may be altered or amended at any regular session of the association by a vote of two-thirds of the members present providing the change is recommended at least one day before the vote is taken.

BY-LAWS OF THE ASSOCIATION

1. A portion of the Scripture shall be read and prayer offered at the beginning of each morning and afternoon session of the association and prayer shall be offered at the close of each session.

This is to be done by the Moderator or someone appointed by him.

2. The Moderator or Assistant Moderator shall call the association to order at the hour designated by the program committee.

When neither the Moderator nor the Assistant Moderator is present, the Recording Secretary shall call the association to order and a President Pro Tem shall be elected by the body, who shall preside for that session of the association.

- 3. It shall be the duty of the Clerk to enroll the delegates of the association who shall present themselves with proper evidence of their right to seats therein, and those enrolled by the Clerk shall compose the association.
- 4. Each organization represented in the association shall send into the association as large a contribution as they can from time to time. This money to be used to meet the expenses of the association and to promote the work it undertakes.
- 5. On the first day of the association meeting the Moderator shall appoint a resolution committee to consist of three members, all resolutions not connected with the reports of boards and committees shall be referred to this committee, which shall report on all resolutions referred to it, with or without recommendation.
- 6. The executive board of the association and all boards shall be elected by the association. All other committees may be either appointed by the Moderator or elected by the body.

- 8. The duties of the executive committee shall be as follows: (1) To act for the association on matters that demand its consideration between the regular annual sessions of the association. (2) To have oversight of arrangements for meetings of the association with authority to change, if necessary, the time and place of meeting. (3) To fill vacancies in the association that may be caused by death, resignation, etc., between the regular sessions of the association.
- 9. It shall be required of all members of the association to remain throughout the entire session unless they are excused by the Moderator.
- 10. Anyone desiring to speak shall rise and address the president, and shall wait until he is recognized before speaking further.
- 11. The president shall not allow discussions that are unchristian in spirit and that tend to create envy and strife among the brethren, and anyone resenting the ruling of the president in such matters shall be liable to censure of the body.
- 12. No one shall be allowed to speak more than 15 minutes or more than twice on the same subject without permission of the body.
- 13. It shall be the duty of the president to have his annual message so prepared and arranged that is can be handed to the secretary for publication in the minutes of each session of the association.
- 14. The officers of the association, except that of the Board of Trustees, shall be for a term of two years.
- 15. These by-laws may be altered at any regular session of the association by a vote of two-thirds of the members present, providing the change is recommended at least one day before the vote is taken.
