## **Thursday Afternoon**

Dr. David Gibbs participated with our state body in a question and answer session. Below is a brief summary of the question and answer session:

(Please realize that these were taken "on the fly" and should not be used as legal opinions without getting ALL the facts about an issue).

- 1) Consent Forms are absolutely necessary for church activities. Without them you are totally exposed in the event of an accident or abuse. Fill them out; file them away.
- 2) The Church Nursery should be one of the most critical areas of oversight in the church:
- A) ALL Nursery Workers need to go thru a screening process that includes a background check and is repeated at least every two years.
- B) There should be at least one worker for every 6-8 children in the Nursery (More than this opens you up to lack of proper supervision if anything happens).
- C) A DOCUMENTED training program should be in place for all Nursery workers.
- D) Nursery workers list should be kept on file so you can tell exactly who was in the Nursery on a specific date- In court it would go something like this: The attorney would ask you if you received an offering each week. He would then ask if you kept records of the money received by the Church so that you could tell him what your offering was 4 months previously. His question then becomes, "If you can tell me how much money you collected four months ago but you cannot tell me who was in your Nursery four months ago, does that not mean that you value money more than you value children?"
- 3) Churches MUST issue W-2 forms to their Pastor and other employees each year. According to the B.J. Worth Income tax guide, Churches who fail to prepare W-2's for their employees are subject to many penalties.

This may also open the door for the IRS to look into other areas of the Church finances.

- 4) Any money given to a minister, singers, or others who come to your church and perform a "service" (such as preaching or singing) is taxable (to the person receiving it) if it is given by the Church. It can be called a "Love Offering" or a "Personal Gift" or anything else but if it goes from the Church to a person it is taxable and the person must pay taxes and social security on this income. It is not taxable if it goes from one nonprofit organization to another nonprofit organization (For instance, from a Church to the SCFWB State Office) or if it is used in a specific guideline Benevolent program. (Individuals can give gifts to other individuals that are tax free but as soon as the money enters the Church Offering plate or comes under the control of the Church it becomes part of the nonprofit organization and the rules about being taxable apply)
- 5) In order for you to refuse to allow a homosexual couple to join your young married class at Church you must have your belief clearly stated in your constitution and bylaws. The Church constitution and bylaws should be reviews by the Pastor and Deacon Board each year to make sure it contains up to date information.
- 6) In almost all cases a judge will allow "inactive Church Members" to vote if they still exist on a church roll. A Church needs an automatic process that removes people who do not attend church for a certain period of time from the Church roll. (This does not mean it removes them from our prayer list or from the list of people we are attempting to get to make a firm decision for Christ).
- 7) It is important that we learn, and follow, the laws of the land as long as they do not violate the laws of the Lord. It is one thing to be in jail for preaching Christ- another thing all together to be in jail for failure to pay taxes!

# 2003 SCFWB State Office and Christian Bookstore Report

South Carolina Free Will Baptists Churches are growing and building and reaching souls for Jesus all across our State. It was the great joy of the Executive Secretary and Assistant Director to **visit** in most of our churches and in almost all of the conference meetings again last year. We were encouraged by the continued Progress we see.

The SCFWB State Office continues to **oversee the finances** for the operation of the State Office, the SCFWB Plan of Support, the FWB Christian Book Store, the SCFWB State Home Mission Board, the Prosser Trust Fund, the Paula Jones Medical Fund, the Pam Hackett Medical Fund, the SCFWB Minister's Benevolent Fund, the Historical Commission Fund, the SCFWB CTS Fund, the Travis Poston India Land Fund, and the South Carolina Vision Fund for India. In addition we assist with the finances for special projects for Missionaries and Conferences.

The Office also helps Pastors seeking churches and churches who are seeking a Pastor. Tax and other forms needed by churches; and prayer and support needs for missionaries forms are also provided through the office.

Information is also provided by maintaining our state web sitewww.SCFWB.Com (Where a web page with picture of the Church and the Pastor; as well as a map to the Church has been provided for most churches in our State Association) and by publishing our state newspaper, "The Informer" (32,000 in 2003).

The State Office continues to trim its operating budget as much as possible-Changing from Pitney Bowes to another Postal company saved us over \$1500 per year. Changing from Bellsouth to another carrier has saved us nearly over \$500 in 2003. Negotiating with motel chains saves nearly \$20 per night at most places we stay.

We appreciate everyone who contributes to the State Office so we can do the work God has called us to accomplish. We encourage those churches who are not supporting to consider putting \$50 per month in their budget for the work of the State Office. God is doing a great work among Free Will Baptists in South Carolina; let's keep up the progress.

#### NOTE 1: Organization and Nature of Activities

The Free Will Baptist Home for Children (the Home) is a corporation whose purpose is to provide care, support, and training for dependent and needy children. It is located in Turbeville, South Carolina and was established in 1949. The Home operates under the authority of the South Carolina State Association of Free Will Baptist, Inc., which appoints members to the board of directors for the Home.

The Home's funding comes from contributions from Free Will Baptist Churches both inside and outside of South Carolina and from the general public. It also conducts various fund-raising events during the course of the year.

#### NOTE 2: Basis of Accounting

This financial statement has been prepared on the <u>cash receipts and disbursements basis</u> of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. The statement reflects <u>all</u> receipts of cash into the operating account and <u>all</u> disbursements of cash from the operating account during the year. Purchases of equipment and fixtures are not capitalized and depreciated. They are shown as expenses. In addition, payments of principal on loans are reflected as expenses for debt reduction.

#### NOTE 3: Income Taxes

The Home is a nonprofit organization as described in Section 501(c)(3) of the Internal Revenue Code and is exempt from federal and state income taxes.

#### NOTE 4: Property and Equipment

This statement is prepared on the cash basis of accounting. Expenditures for purchases of equipment and fixtures are not capitalized but rather are shown as expenses.

#### NOTE 5: Depreciation

This statement is prepared on the cash basis of accounting. Depreciation has not been recorded.

# Appendix VII SC FWB Home Missions Report Report of the Hispanic Ministry, Una, SC

On June 4, 2002 our family arrived in USA. At that time everything was different for us...language, people, culture, etc. Many Christian people from Free Will Baptist churches in South Carolina were our new family. We can feel love every time. When we were looking in the Una area, we could only see African American people, Mexican, and Una FWB Church building. At that time we hoped that God will work and some people will know Jesus and the Good News. We remembered our first visit to Wal Mart for distributing Spanish Tracts. The first people were invited to come to the church. Our first Service was a Christian movie (The Appointment) and 18 people came to the service on Thursday. But when the next Sunday came, we had just 5 persons...The Hispanic Church was starting.

It was necessary to work every day, every hour, every place (trailer parks, supermarkets, gas stations, flea markets, jail, hospital, highways, laundry places, and more. Where Hispanics were, we could see God working with the Hispanic people, little by little...Each one was coming to the church...sometimes yes, and sometimes, not.

Different "weapons" were used for search of Mexicans...signs, Spanish tracts, newspaper, radio, special singing service, and visitation. God gave us different ways that we could see. Mexican people are special and different people. They need to have trust from us.

So, 15 people starting coming, and these people talked with other people, and a few others came. It is not easy for us to tell you everything we've done in 17 months working here in Una. We would have a lot to say, because each one Mexican family is equal to each to each one different problem and situation. Our church was growing each time. God is blessing, but it is necessary to be ready for work...so, God gave us more souls for Him.

Last Sunday, February 1, our church was "full": 106 persons came and 4 souls were saved. This number is not normal every Sunday...sometimes we have 55 or 65 or 99 or 55 again! But we are sure God is with us! Right now my wife is working with young people, and the students help her with it. Many times we have a lot of work to do, and we don't have much time...days have just 24 hours.

Many Mexicans need help for search of a job, help with filling out applications, Health Department, Hospital, and much more! We

remember when we had six at the Hispanic Church. Mexicans move every time from North to South and East to West. This is a real problem because 20 people from our church have gone to other places in the United States. Right now, we have a family (Brother Tito and Sofia) from our church that we are training for the last year, and they are ready to work for Jesus here in SC or at another state.

It is necessary to go ahead with the Hispanic Ministry...Jehovah's Witness, Jesus Only, and Mormons are working with Mexicans right here in Spartanburg!

Pamplico (Beulah FWB) is a new challenge too. We are going once a month. We would just like to say THANKS for all you do for us and the Hispanic ministry. I'm sure without American churches and brothers and sisters help, never Hispanic church started. Your help is important!. Thanks you for your love. We appreciate it!

# **Historical Commission Report - Joe McKnight**

History never looks like history when you are living through it. It always looks confusing and messy, and it always feels uncomfortable. ~John W. Gardner Things would be so much simpler had the early Free Will Baptists in South Carolina realized how much the later generations would need to know. They could have left volumes of information and documentation that could be easily accessed. It certainly would have made the historian's job easier. But, as the quotation by John Gardner tells us, they didn't have the luxury of seeing the circumstances of their lives as historical subject matter. They were too busy trying to provide the basic requirements for their families, and trying to build a church centered upon the truth of God, as they understood it. So, it becomes our duty to diligently examine the fragmentary evidence that is available if we are to truly understand our heritage.

During the year of 2003, we have learned much about the people, events and forces that formed the Free Will Baptist faith in South Carolina. This knowledge is essential if we are to truly have a sense of identity. However, the greatest lesson we've learned is that there is so much more we don't know. So, we will use this upcoming year as a time to dig deeper into the historical record. We will continue to focus on the pastors and ministers whose labors and sacrifices built the framework of our conferences/associations and the current State Association. We'll also begin to examine the early churches, many of which are still in existence today. At some point in 2004, we'll focus on the theological and doctrinal issues that built, shaped and threatened our denomination in those early years. But, in the midst of all that, we cannot overlook the humanity of our ancestors. So there will be time for the human-interest stories. One such story will focus on the Civil War-era account of the Free Will Baptist woman whose desperate search for her missing soldier-husband took her on a rugged thousand-mile journey.

If you enjoy these articles, there is a way you can participate in this work. The Historian's Office does not receive regular funding of any kind. At present, there is a deficit balance in our account at the State Executive Office. This greatly inhibits our ability to do research and acquire historical documents.
