South Carolina State Association  
Fairview Free Will Baptist Church, Spartanburg, SC  
February 26-27, 2009

Bro. Bruce Kimbrel opened the 2009 state meeting with a congregational hymn and Dr. Don Hanna opened the meeting in prayer. Bro. John Johnson (EC) shared a devotion from Mark 2:1-5 and then, as clerk, called the meeting to order. Bro. Tim Hackett (BC) pastor of Fairview FWB Church gave the host pastor welcome. Assistant Moderator Bro. Buddy Seay (CA) gave the response and introduced the moderator Bro. Sherwood Lee (SC).

It was MSC to accept the partial Credentials Committee report.

It was MSC to seat the delegates and to proceed with a flexible program.

The moderator recognized all visitors including missionaries that were present along with representatives from our national agencies.

It was MSC to receive the Committee on Committee report (Pg 10). It was announced that Bro. John Johnson would be leaving the state and would not be able to continue as the state clerk. The nominating committee was excused to meet due to the need to elect a new clerk early in the session in order to work with the current clerk while in session.

It was MSC to accept as information the National FWB Executive Office report as given by Bro. Keith Burden, the NAFWB Executive Secretary.

Bro. Mike Jones (SC) was nominated by the nominating committee and elected as the new clerk.

It was MSC to accept the report of the Executive committee and General Board. (Pg 8-9)

Mrs. Pam Hackett gave the WAC Report. It was MSC to receive this report as information. (Pg 26)

The State Office and Bookstore Report (Pg 14) was given by State Executive Secretary Bro. Todd Smith. Bro. Mike Jones who has been helping in the bookstore gave information concerning financial audits of the State Bookstore. Bro. Todd also gave information concerning the SC Foreign Missions plan of support. He noted that only about 15% of monies that are received through the state office are a part of this plan. We were reminded that Neil and Mandy Morgan who have recently been approved as missionaries and are from South Carolina are not yet a part of this plan. It was MSC to receive this report.

The following motion was MSC:

Motion made to allow the Executive Committee to study the current SC Foreign Missions Plan of Support in light of 2010 changes and include new missionaries from SC to the SC Foreign Missions Plan of Support and adjust the percentages accordingly.

The Credentials Committee Report (Pg 12) and the State Treasurers Report (Pg 13) were given by Bro. Marty Cox (CA). It was MSC to receive these reports.

The SC State Student and Children's Ministries Report (Pg 30) was given by Bro. Bruce Kimbrel (SC). It was MSC to receive this report.

The SC State Youth Ministries Report (Pg 27) was given by Bro. Cyrus Shoffner. Bro. David Ulrich from the Anchorage in Whiteville, NC gave information concerning the teen camp program. It was MSC to receive this report.

The session was recessed until 11:00 AM.

At 11:00 AM the meeting was reconvened. by Bro. Bruce Kimbrel (SC) led in "My Jesus I Love Thee". The delegates then enjoyed special music sang by Trina Ross from Fairview FWB Church. Bro. Tim Hackett pastor of Fairview FWB Church brought the morning message from Jeremiah 24:7 entitled "How Do You Know God".

After a gracious lunch provided by the host church the delegates were led in the hymn "To God be the Glory" by Bro. Bruce Kimbrel (SC). Prayer was offered by Bro. Reedy Saverence (SC). A devotion was given by Bro. Lee Patrick (SC) on being "There" from 1 Kings 17:1-7.

When business continued Bro. Marty Cox (CA) was elected as the State Treasurer and Bro. Wayne Snipes (CA) was elected Assistant Treasurer.

The SC State Home Missions Report (Pg 22) was given by Bro. Earl Hendrix (BC). Bro. Hendrix noted the problems that were occurring between the SC State Home Missions board and the National Home Missions board concerning the joint project status of the mission work in Aiken, SC. He emphasized the board's desire to meet with the National Home Missions Board and resolve the situation. He also thanked Bro. Theron Scott for his diligent work concerning this problem. Executive Secretary Bro. Todd Smith then gave explanation and information concerning SC State Home Missions financial reports. It was MSC to receive this report.

The following motion was MSC:

Motion made that the SC State Association request a meeting between the National Home Missions Board and the SC State Home Missions Board concerning the Aiken Home Mission Work. This request is to be made to the National Association of Free Will Baptists.

Bro. Mitch Edge (BC) was elected to replace himself on the Home Missions Board. Bro. Darrell Morgan (PC) was elected to replace Bro. Daggett Duncan (PC) in his unfulfilled term on the Home Missions Board due to health reasons.

The Children's Home Report (Pg 31) was given by Bro. Roy Roach. Bro. Roach reported that currently there were only four children at the home and addressed concerns about current and future needs at the home. Bro. Tim Hackett, Children's Home Board Chairman also

fielded questions regarding the Children's Home and possible future problems. He also gave information concerning regulations that could be changing that would affect the Home and addressed questions that were raised about salary raises and other budgetary matters. It was MSC to accept this report. Bro. Roach then gave out awards to the top giving churches to the Children's Home.

Larry Collins was elected to replace himself on the Children's Home Board.

Bro. Bruce Kimbrel was elected to the Youth Ministries Board.

Bro. James Sanders (BC) and Bro. Doug Mathis (EC) were elected as Members at Large to the State General Board.

Bro. Jeff Cockrell was elected as Assistant Clerk (SC).

Bro. James Forlines gave the Free Will Baptist International Missions Report and showed a short video about missions. It was MSC to receive this report as information.

Bro. Carlisle Hanna brought greetings from the mission works in India. He was greeted with a standing ovation as delegates honored Bro. Hanna for his lifelong service of bringing the gospel to the country of India. He also gave information concerning his status and recent difficulty in securing the correct visa that he needed. Bro. Neil Morgan was then recognized and gave information concerning his mission itinerant as he prepares to go to Uruguay.

The meeting was recessed for ten minutes. After the break the delegates sang "Victory in Jesus" led by Bro. Bruce Kimbrel.

It was MSC to receive the Board of Retirement Report given by Bro. Ray Lewis.

The FWB Bible College Report was given by Dr. Matthew Pinson. It was MSC to receive this report as information.



Dr. Lorenza Stox brought greetings and a report from Southeastern FWB College. It was MSC to receive this report as information.

It was MSC to receive the Randall House report as information which was given by Randy Walser.

Gateway Christian College brought greetings and a report by Daniel Smith. It was MSC to receive this report as information.

It was MSC to receive the FWB Foundation report as information. The report was given by David Brown.

The session was recessed until 7:00 PM for the evening worship service.

## Thursday Evening

The evening worship began with a mass choir that was led by Bro. Bruce Kimbrel (SC). Bro. Brian Tolliver (EC) was asked to open the meeting in prayer. An offering was received for the State Home Missions Board and the Fairview FWB Church praise team offered a time of special music. Executive Secretary Todd Smith recognized the top giving churches in SC and then honored Horse Branch FWB Church and Pastor Mike Edwards with a plaque naming them as the top giving church in the state for the year.

Dr. Lorenza Stox, president of Southeastern FWB College preached the evening message from Titus chapter two entitled "Those Who Make Him Known". An invitational hymn was led by Bro. Bruce Kimbrel.

Moderator Sherwood Lee presented the evening offering to Bro. Earl Hendrix who received it on behalf of the State Home Missions Board.

## Friday Morning

Bro. Rick Bowling gave the Hispanic Ministries report and recognized Bro. Ricky Evans (CA) who related to the body what a blessing the Hispanic Ministry has been to his church. It was MSC to receive this report as information.

He stated that he had met with the SC Home Missions Board at this state meeting and was in the process of scheduling a meeting between the National Home Missions Board and the SC State Home Missions Board. Information was given by Bro. Mike Jones (SC) about the SC Foreign Missions Plan of Support concerning changes that will be implemented by the Executive Committee in light of the previous motion that was made (Pg 12) .

The resolutions committee report (Pg 11) was given by the clerk Bro. John Johnson. It was MSC to receive this report.

It was MSC to give the Fairview FWB Church and the Beaver Creek a rising vote of thanks for hospitality.

The following motion was MSC: Motion made to send a letter to the current president and administration to encourage him that we would pray for him and that he would endeavor in righteousness and to whom much is given much is required.

A motion was MSC that the SC State Association give Bro. Carlisle Hanna a rising vote of love and appreciation and a renewed vote of love and support for His long time ministry in India.

Bro. Buddy Seay was elected as the Assistant Moderator. Bro. Sherwood Lee was elected as the Moderator

Bro. Galen Dunbar (SC) encouraged churches to support the WMO. The goal for the coming year is \$600,000.

There were various announcements made. Bro. Paul Reid was elected as the State Historian.

There was a break until 10:45AM.

After returning from the break the session was led in “Revive Us Again” by Bro. Bruce Kimbrel. Dr. Matthew Pinson offered prayer. After worship in song by Bro. Eddie Carter (CA) and his wife, Bro. Carter preached from 1 Chronicles 4:9-10 on “How can we know Him and make Him known”.

## SC FWB State Office and Christian Bookstore Report

The well known reformer Martin Luther said, “I have tried to keep things in my hands and lost them all, but what I have given into God's hands I still possess.” Many of you have experienced this great truth that Martin Luther had learned in his own life. 

**Subject: Audit of the financial records of the South Carolina Free Will Baptist State Office and Christian Book Store.**

A careful review of the financial records of the South Carolina FWB State Office and Christian Book Store found the following:

- All State Office and Book Store bank accounts were in balance and were reconciled with bank statements monthly.
- Paper and electronic copies of receipts were available for all accounts and random receipt and deposit checks on all accounts met with no discrepancies.
- Monthly reports are given to the State Executive Committee on all State Office Operations accounts and these reports reconciled with actual computer records.
- State Office Operation accounts and State Book Store accounts are both monitored by State Executive Secretary, Todd Smith and Book Store Manager, Linda Tanner thus maintaining multiple over sight over these accounts.
- The Designated Funds Gifts Accounts for the support of missionaries and ministries are reconciled each month through a double system of Bank Account reconciliation and Zero Balance accounting (All gifts into this fund must be distributed each month so as to achieve a "Zero" balance).
- Designated Funds Gifts are published in the State Paper (The Informer) each year to enable each donor to compare the amount listed as being given from them to the amount actually given by them. Any inquiry concerning gifts discrepancies is investigated until a clear and satisfactory explanation is understood by both parties.
- Because of the sickness of Book Store Manager, Linda Tanner, during 2008 former State Executive Secretary, Mike Jones, has worked at the Book Store on numerous occasions. The need to assist with payroll and Book Store operational needs have necessitated access to the State Office, as well as the Book Store Funds accounts. No limitations were places on access and no discrepancies were observed.
