Bro. Keith Burden brings greetings from National Executive Office. Offered thanks to the state for allowing Bro. Todd Smith to serve on the National Executive Board. SCFWB State Office & Christian Bookstore Report

Churches and individuals gave \$1,230,124.35 to missionaries and ministries at home and around the world through the South Carolina Free Will Baptist State Office in 2012. This is \$50,643.96 over 2011. Giving to some ministries was up and some were down, but large increases include gifts to Free Will Baptist International Mission, including the World Mission Offering (WMO), gifts to Brother Fernando Bustamante's account which was up \$17,925.28 over the previous year, and gifts to Friends of India which was up \$19,752.30 over the previous year. We praise the Lord for these and other increases. Whether your church gave a little or a lot, every dollar makes a difference in helping missionaries and ministries.

Our SC FWB State Office scaled back to two employees and part time help as needed compared to three employees and part time help a year ago. Cut backs in Sunday school literature sales made this change necessary. *Business Week* magazine indicated that overall book sales were down 2.5% in 2011 from the previous year due to e-book sales. With the evolving market of digital technology, we believe we will continue to face similar challenges in the future in our Christian Book & Supply. Your support for our SC FWB State Office is greatly needed and appreciated. Every dollar you give enables us to be a voice for our missionaries on their various fields of service. Thank you for giving to the Lord!

Business Conducted: Delegates were appointed to the WNAC Annual


