Minutes of the SC Home Mission Board Meeting

SC Home Mission Board, April 10, 2013. Brother Mitch Edge opened in prayer. Introduced new members, Brother Chris Johnson (CC), Brother Chris Todd (BCC). Discussed insulation issues at the Aiken work and that it would take about \$2200 to complete the project. Brother Jim Fairchild stated he would like \$10K to \$12K in his acct before they spent any money. He suggested that the funds for the insulation come from the church fund and not the mission fund. After hearing the financial report the board decided to pay half from the mission fund and half from the church fund. Discussion of salary helps from the church. The tithes at the church were down due to some good tithers leaving the church there was not enough to pay a large amount of the salary help. Pamplico property was discussed and decided to sell and the process in which it would be sold. The amount was set at \$249,000 since a verbal appraisal was given at around \$200,000. The property set to sell with Brother Allan Austin contacting some prospective buyers. Also, some water bill issues. There was discussion of church plants and models for doing a better job than had been in the past. As well as church growth as a whole. Brother Larry McAllister made a motion to go to a church growth conference and find ways to do that. It would be something the board could use to help pastors across the state. Brother Chris Johnson seconds the motion and it carried. Brother Jim Fairchild shared about the disability baseball program. The meeting dismissed with some prayer request and then to lunch. Members present. Brother Chris Johnson (CC), Brother Chris Todd (BC), Brother Larry McAllister (EC), Brother Chuck Thornton (PC), Brother Allan Austin (SCC), Brother Mitch Edge (Director), Brother Todd Smith (Executive Director), Brother Jim Fairchild (Missionary)

SC Home Mission Board, June 10, 2013. Brother Mitch opened in prayer. Discussion began with Aiken work. Brother Jim Fairchild had resigned and left the beginning of June. There was unrest among the leadership of the church. There were some who had expressed interest in going to take the work and those names were discussed. There were issues in the Aiken area that had to be considered. Brother Todd Smith discussed the finances. There was discussion of fill-ins and expenses for those who would be there. Much prayer was to be put into the Aiken work and consider what the next steps were. Pamplico property update with no change. Dismissed in prayer and to lunch.

SC Home Mission Board, September 12, 2013, Meeting held at the Columbia Free Will Baptist Church at 10 am, Members present were Brother Mitch Edge, Brother Chris Todd, Brother Chris Johnson, Brother Allan Austin, Brother Larry McAllister and Brother Todd Smith. Brother Mitch opened in prayer. Discussion about Brother Larry Monday helping the Southside Church in Aiken with finances and computer information about members. Money is being held and it has not been handled properly. Church men are working to upgrade the looks of property. We discussed the issue of insulation being installed and who would

pay for it. They understood the Mission Board would pay all and the April meeting minutes state the Board pays half and the church pays half. Discussion of the church payment of tithes to the Board for expenses. Then we discussed resumes and especially Brother Larry Monday. Salary was discussed as to full-tine verses part-time. Would the income and moneys from the Board be able to support the missionary full-time or would he have to get a job. The Board discussed meeting with the leadership of the church and Brother Larry Monday. A meeting was planned for September 28, 2013 at 10:30am to do just that. Brother Chris Todd mentioned from the meeting in April about vision and direction of the Board. Vision Statement and Mission Statement for the Board Brother Chris Todd will develop a Purpose Statement. Input from the Board for statement: Evangelism, support, Training, and Church growth. Brother Todd Smith gave the financial report. He also stated the Town of Pamplico had called and was taking the trash off the water bill and would decrease the bill. We dismissed in prayer and went to Lizard Thicket to eat lunch.

SC Home Missions Board, Oct. 17, 2013, 10am, Columbia FWB Church, Columbia, SC. Brother Mitch Edge opened in prayer Chris Todd thanked the Board for meeting in Columbia for family reasons. Brother Todd Smith went over the financial report. Board discussed monthly reports and amounts, percentages and dollars amounts. How much the missionaries are sending to support their accounts. Brother Chris Todd shared the Vision Statement and the board discussed ways to implement it. The board will make seminars and conferences to aid churches and ministries within the state to train and encourage. These sessions will be done statewide and/or regionally. Brother Mitch Edge passed out a discussion he had with Brother Larry Monday. The board discussed pay package and issues with Brother Larry Monday. There was a recommendation to vote to hire Brother Monday as the pastor/missionary for the Southside Church in Aiken, SC. The vote will reflect the pay package with the option housing. The board will look into putting housing on the property. The board will research those possibilities. The vote is to elect Brother Larry Monday as pastor to begin on November 3, 2013 as full-time. Members not present were: Brother Larry McAllister, Brother Chris Johnson, and Brother Chuck Thornton. Voting members: Brother Chris Todd, Brother Mitch Edge, Brother Allan Austin, Brother Chris Johnson, and Brother Larry McAllister. Brother Chuck Thornton was not present and did not vote. The vote was unanimous to elect Brother Larry Monday as pastor/missionary for Southside FWB Church in Aiken. Present at meeting were: Brother Mitch Edge (Director), Brother Chris Todd (BCC), Brother Allan Austin (SCC), Brother Todd Smith (Executive Director).

SCFWB Home Missions Report: We at the SCFWB Home missions board would like to say thank you for your support. We are all very excited about the direction our home missions board has taken. We have in the past year adopted a vision statement. The Bible says where there is no vision the people perish. Our

vision is: to labor to fulfill the great commission of the Lord Jesus Christ through evangelizing the unsaved by implementing new works as well as providing assistance, support, care and training to existing works to be a friend to the local church as well as the pastor in order that we might labor to gather in this vision. Because of this vision the home missions board has adopted a five tiered approach to ministry. 1. Personal evangelism, 2. Minister training, 3. Equipping the Saints, 4. Assisting churches, 5. Planting churches.

REPORT OF THE RESOLUTIONS COMMITTEE: We, the Resolutions Committee, submit the following resolutions to the SCFWB State Association.

SCFWB EX. COMM. MEETING, Nov. 19, 2013

In a collective and unified effort, the SC FWB Executive Committee, FWB Home for Children Board, and conference moderators met on 11-19-13, at the request of the Children's Home Board to discuss the future of the Children's Home ministry. In a spirit of harmony, the following recommendation was submitted and passed unanimously by the SCFWB Executive Committee:

"To appoint a committee to conduct a feasibility study of utilizing the Children's Home property to produce reciprocal income for the SCFWB State Ministries and to bring a recommendation to the SCFWB State Association at their next meeting in February 2014" (MSC).

The following committee was selected by the Executive Committee:

- 1. Rev. Tim Hackett, Chairman of the Feasibility Study Committee
- 2. Mr. Larry Hawkins, Chairman of the Children's Home Board
- 3.Mr. James Beasley, Chairman of the Oversight Financial Committee of the Children's Home.

The committee was also given permission to select additional members in their area of expertise. This recommendation is for the enhancement of all South Carolina Free Will Baptist Ministries, and during this transition period, continued financial support is encouraged and needed.

Bethlehem FWB Church in Hartsville closed and sent a check for \$24,885.76 and requested the funds to be disbursed according to Executive Secretary's Todd Smith's discretion. He brought this before the Executive Committee, and it was MSC to disburse the funds equally between the five state ministries: Children's

Home, SC Home Mission, SC FWB State Office, Youth Ministries, and SC Women Active for Christ.


