Minutes of the SCFWB 76TH Annual State Meeting, Feb. 22-23, 2018

Meeting opened with a message by Bro. Jim McComas, North American Home Missions - "THREE ROADBLOCKS TO REVITALIZATION"

Welcome by asst. moderator, Bro. Danny Stone.

Introduction of SCFWB moderator, Bro. Sherwood Lee.

Welcome by moderator.

<u>Partial credentials</u> committee report given by Bro. Scott Ard. We have 5 conferences represented, 104 churches, received \$24,440 in fees/dues, 46 ministers, 9 delegates, 7 national reps, 1 missionary, and 17 visitors with a total attendance of 80. All conferences have reported, all fees have been submitted and it is recommended to have the delegates seated. MSC

Bro. Sherwood gave greetings to our various missionaries.

Motion to seat delegates. MSC

Motion to have a flexible program. MSC

Visitors recognized.

General Board report and Executive Board meetings reports given by clerk, Bro. Tommy Hill. Motion to accept general board report. MSC International and Home missionaries introduced and welcomed.

State Executive Secretary report given by Bro. Chris Todd. Report can be viewed in the Minutes booklet. Motion to have a feasibility study to determine if SC can be a future host for our National Convention. MSC. Motion to receive report. MSC

Bro. Chris Todd gave the report regarding the proposed changes to the State Constitution. The following items detail the changes that were voted on and changed. All the changes have been made in the updated SCFWB Constitution and By-Laws which can be viewed on the state website.

Changes to SCFWB Constitution and By-Laws. The numbered item identifies what has been changed. The indented section that follows shows the current reading of the constitution and by-laws before the change.

- 1. Sec. T Human Sexuality. The word "metrosexuality" was replaced with the word, "transgenderism." Transgenderism better defines the concern identified under Human Sexuality.
 - a. (T) Human Sexuality.
 - b. 1. We believe that God has commanded that no intimate sexual activity be engaged in outside of marriage between a man and a woman. We believe that any form of homosexuality, lesbianism, bisexuality, bestiality, incest, fornication, metrosexuality, adultery and pornography are sinful perversions of God's gift of sex. Any employee of the state becoming pregnant or causing pregnancy as a result of consensual intercourse, outside of the marriage relationship, shall be terminated from employment. (Gen. 2:24; Gen. 19:5, 13; Gen. 26:8-9; Lev. 18:1-30; Rom. 1:26-29; I Cor. 5:1; 6:9; I Thess. 4:1-8; Heb. 13:4).
 - c. 2. We believe that the only legitimate marriage is the joining of one man and woman. (Gen. 2:24; Rom. 7:2; I Cor. 7:10; Eph. 5:22-23).
- 2. Sec. W Divorce and Remarriage. The words, "and abandonment" and the scripture reference, "I Corinthians 7:15" have been added to this section.
 - a. (W) Divorce and Remarriage. We believe that God hates divorce and intends marriage to last until one of the spouses dies. Divorce and remarriage is regarded as adultery except on the grounds of fornication. Although divorced and remarried persons or divorced persons may hold positions of service in the church and be greatly used of God for Christian service, they are not to be considered for the office of pastor or deacon. (Mal. 2:14-17; Matt. 19:3-12; Rom. 7:1-3; I Tim. 3:2, 12; Titus 1:6).

- 3. Art. V, Sec. One, Method of Selection: The number, "six," was replaced with the number, "five." We now only have 5 conferences that make up the SCFWB State Association.
 - a. ARTICLE V STATE REPRESENTATION TO THE NATIONAL ASSOCIATION SECTION ONE: Delegates

<u>Number:</u> The State Association shall send five (5) delegates to the National Association annual convention. This number is determined by the national body.

Method of Selection: Each conference or association shall have the privilege of nominating one delegate to represent the South Carolina State Association of Original Free Will Baptists, Inc. at the annual meeting of the National Association of FWB. If any conference fails to nominate a delegate or the delegate is unable to attend then the State Association Moderator will choose delegates from available laymen with consideration given to representation from all conferences. If all six conference delegates are able to attend the National Association, then the State Moderator will designate one of them as an alternate on a rotating basis

- 4. Art. VII, Officers, the following has been added, "Member-at-large (Upper State), Member-at-large (Lower State).
 - a. The officers of this association shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer.
- 5. Art. VII, Sec. Two, Duties: Duties added for Members-at-large. "It shall be the duty of the member-at-large to represent the members from their respective conferences to the state."
 - a. This is a new addition, there was no previous duty written.
- Art. VIII, Sec. One, Executive Committee, Composition. The following is to be added, "member-at-large (upper state), member-at-large (lower state).
 - a. Composition. The Executive Committee shall consist of the Moderator, Assistant Moderator, Clerk, Assistant Clerk,
 Treasurer, Assistant Treasurer. One member-at-large is to be from the upper state conferences (Beaver Creek Conference, True
 Life Conference), and one member-at-large is to be from the lower state conferences (Eastern Conference, Central Conference,
 South Carolina Conference).
- 7. Addition on page 10 of Art. IX Boards and Directors, Section One: Boards with Directors, 4. South Carolina Free Will Baptist Disaster Relief Board. This is a new addition.
- 8. Article XI, Printing of the Annual State Minutes and the Constitution and By-Laws, Section Three: The Constitution and By-Laws. A copy of the constitution is available to view or download at the state office website. The state clerk will update the constitution as changes occur.
 - a. Section Three: Printing of the Constitution And By-Laws. The Constitution will be printed only when changes are made to the constitution. A copy of the constitution is available to view or download at the state office web site.
- 9. All the Boards that are a part of the SCFWB State Association will include in the Preamble the following statement, "The ____ Board of the South Carolina State Association of Original Free Will Baptists, Inc. do hereby adopt the Articles of Faith and Constitution and By-Laws of the South Carolina Free Will Baptist State Association to govern its activities."
- 10. SCFWB Youth Ministries constitution and by-laws complete change.
 - a. Constitution and By-Laws of the State Youth Conference of the Original Free Will Baptists of South Carolina.

PREAMBLE

We, the Original Free Will Baptists of the State Youth Conference of South Carolina, in order to advance the cause of the Lord Jesus Christ do hereby adopt the Articles of Faith and Constitution and By-Laws of the South Carolina Free Will Baptist State Association to govern its activities.

ARTICLE 1 – NAME: This organization shall be known as the State Youth Conference of the Original Free Will Baptists of South Carolina (Hereafter called the State Youth Conference).

ARTICLE II – PURPOSE: The State Youth Conference is that agency within the structure of the State Association responsible for promoting the Biblical, musical, and artistic training program throughout the state. The State Youth Conference should be a time of unusual inspiration and challenge to both youth and adults. The State Youth Conference shall be under the supervision of the State Association of Original Free Will Baptists, Inc. Selection of the state's representatives to the various competitive activities sponsored by the National Youth Conference program shall be made at the annual State Youth Conference.

ARTICLE III – BOARD: SECTION ONE: Composition: The State Youth Conference board shall consist of a Director and (5) Board members. SECTION TWO: Acquisition: The Director and Board members are elected by the State Youth Conference body at their annual session. Their term of serve begins immediately upon election. A report of those elected shall be presented to the State Association at their next annual meeting. SECTION THREE: Duties: The duties of the Board are as outlined in the State Association's Constitution.

ARTICLE IV - OFFICERS: The Offices shall consist of a Director, Assistant Director, Secretary, Treasurer, and Youth Chairman.

ARTICLE V – DELEGATES: Each district shall be entitled to represent with five delegates elected by its convention. Each State Youth Conference church holding membership in this convention shall be entitled to represent with one delegate elected by its members. All ordained ministers and all State Youth Conference directors who are State Youth Conference members of this convention shall be entitled to vote.

ARTICLE VI - TIME AND PLACE: This conference shall meet annually in the Spring, at a time and place designated by the State Youth Conference Executive Committee.

ARTICLE VII – COMMITTEES: The committees of this State Youth Conference will be:

- 1. The Executive Committee composed of: Director, Assistant Director, Secretary, Treasurer, and Youth Chairman.
- 2. The Digest Committee, appointed at the beginning of each session by the Director.

This organization or it's Director shall appoint or elect as many special committees as necessity may demand.

ARTICLE VIII – FINANCES: Each local State Youth Conference organization shall represent with a minimum fee of twenty-five dollars (\$25.00) which shall be used to carry on the general work of this organization. Each district State Youth Conference shall be required to send a minimum of ten dollars (\$10.00) for each local State Youth Conference composing its membership.

All representation fees (from State Youth Conference and each participating State Youth Conference composing its membership) must accompany a list of contestants sent to the State Youth Chairman in order for district contestants to compete at the State Conference. (The State will look to the District for payment of all fees.)

Competition fees will also be forwarded to the State Youth Chairman for participants in competitive activities. Said fees will be in accordance with the appropriate Competitive Fee specified in the current National Youth Competition Guidelines.

ARTICLE IX – REPORTS: Each district State Youth Conference shall make a written report on a form provided by the State Youth Conference; each local State Youth Conference shall make a similar report as provided by this organization, for the purpose of compiling adequate records of the growth of State Youth Conference programs.

ARTICLE X – AMENDMENTS: This Constitution may be amended by a vote of two-thirds of the members present at any session of the State Youth Conference.

ARTICLE XI - DUTIES OF OFFICERS: Director: It shall be the duty of the Director to preside over each session, preserve order, govern the body according to established parliamentary usage, and appoint all temporary committees, unless the organization asks that they be elected. The Director will serve on the Executive Committee. Assistant Director: It shall be the duty of the Assistant Director to serve in the full capacity of the Director when he is absent or when he requests the Assistant Director to serve in his capacity. The Assistant Director will serve on the Executive Committee. Secretary: The Secretary shall keep an accurate record of all transactions of the Executive Committee and of the State Youth Conference, preserve the same, keep all valuable documents, and surrender them to his successor in office. The Secretary will also serve on the Executive Committee, shall handle all correspondence of the State Youth Conference, and act as public chairman of the state work.

<u>Treasurer:</u> All money belonging to this organization shall be kept at the State Office and managed by the SCFWB Executive Secretary under the direction of the State Youth Conference Board. <u>Youth Chairman:</u> The Youth Chairman's duties shall be to coordinate all competitive activities. All necessary materials and awards for the competition shall be obtained by the Youth Chairman. The Youth Chairman will serve on the Executive Committee

ARTICLE XII - DUTIES OF COMMITTEES: Executive Committee: The Executive Committee shall arrange the programs for the State Youth Conference. The State Director shall be the Chairman.

Digest Committee: The Digest Committee will count all contributions to the State Youth Conference, compile the reports, and report the results to the conference.

ARTICLE XIII - APPROPRIATIONS

- 1. Members of the Executive Committee shall be reimbursed their travel expenses according to the current year's IRS allowance.
- 2. State Youth Conference winners shall receive from the State Youth Conference assistance in representing our state at the National Youth Convention. The Executive Committee will determine the amount appropriated to each winner, based on the amount available in the treasury. The church and district from which the state winners come are strongly urged to assist the winners financially in participating in the National Youth Convention.

ARTICLE XIV - COMPETITION

- 1. Each district may be represented at the State Youth Conference with one contestant in each category as outlined in the National Youth Competitive Guidelines.
- 2. The winner in the Music and Arts division must have the Highest One Rating to represent South Carolina at the National Association. If the winning contestant cannot attend, the runner-up can represent provided a One Rating was attained.
- 3. Winners in all divisions must be approved by the judges in order to represent South Carolina at the National Association.

ARTICLE XV – AMENDMENTS: Any amendment to the By-Laws may be secured at any session of the State Youth Conference by a vote of two-thirds of those present at the conference.

11. SCFWB Disaster Relief Board. New addition.

Motion to lay the Constitution changes on the table to be considered later during the meeting. MSC

Thursday Morning message given by Bro. David Crowe.

Bro. Joey Postlewaite offered prayer and blessings upon the food. Meeting will resume at 1 pm.

Thursday Afternoon Session

Devotion offered by Bro. Ken Akers on, "Developing Leaders" from Nehemiah 6.

Greetings from the National Executive Secretary, Bro. Keith Burden. Encouraged everyone to subscribe to ONE magazine. The executive office is in the process of developing a revitalization program. More details will be provided at the convention in Little Rock, Ak. Convention theme is, "CALLED."

Bro. Waylon Owens introduced Erik Corcoran (The Nehemiah Network) to SCFWB. Bro. Erik introduced the concepts behind the Nehemiah Network. Told of how it took him 18 years to become an American citizen. America is worth fighting for. We must pray for our leaders. Bro. Erik works to bring pastors and legislative leaders together.

Motion to bring the updating of the constitution off the table. MSC. There will be grammatical corrections made as well as the WAC bylaws included. All in favor in adopting the changes to the SCFWB Constitution please stand, two/thirds vote and the motion carries. MSC.

Report given by Sis. Pam Hackett. Motion to receive SC WNAC by-laws as written. MSC. Some things our state WNAC has done this year, a church in Michigan sponsored a retreat at a castle in France and the SC State WNAC gave an offering (\$250 each) to some our missionary wives (Sis. Johnson, Sis. Morgan, and Sis. Postlewaite) as an encouragement for their part in the mission work. Request was made for pastors to provide the materials to the WNAC group at their churches. Information was provided regarding the SC WNAC upcoming meetings.

The director of the WNAC, Sis. Elizabeth Hodges brought greetings to the SCFWB State. The WNAC had a great year. The Cedars of Lebanon students (15) received scholarship monies, \$1000. The Miley scholarship was founded during the year, the newest international scholarship. Had some great "Shine" conferences with wonderful attendance. Participated in Chapel in Nov. at Seffner Christian School. Held a retreat for the Cuban sisters (400), the ladies raised \$12,000 to host this retreat. It was their first retreat in 10 years. The WNAC is working to get our Cuban doctor to Africa to serve the Lord. We are waiting on the Cuban government to approve this. Please pray for the work that is being done by the WNAC.

The Youth report was given by Bro. Teddy Rabon as well at the Youth Camp ministry report. Bro. Randy Valandingham gave the CTS report. All churches are encouraged to please support our youth camps. Motion to receive reports. MSC. Two board members to be considered (Chris Edwards, Stephen Carlson). Motion to elect new board members. MSC.

The State Treasurers Report was given by Bro. Scott Ard. Motion to receive reports. Executive Board members to be replaced are Bro. Scott Ard to replace himself, Bro. Joey Postlewaite to replace himself, and Finance member Bro. Sammy Sutton to replace himself. Motion to receive these nominations. MSC. Bro. Scott Ard suggests that we replace Bro. Timmy Locklear (Finance Committee) with Bro. Joey Postlewaite for the remainder of the year. Bro. Locklear requested to be removed as he has changed states and is pastoring in NC. Motion for Bro. Joey to replace Bro. Locklear. MSC.

Bro. Steve Berry shared a report from Southeastern FWB College. The college invites all to come to their spring conference. He encouraged churches to bring their young people to the "Welcome" days.

The nominating committee recommends that Danny Stone replace himself as Assistant Moderator, Tommy Hill replace himself as Clerk, Stephen Hyman replace himself as the Assistant Clerk, Wayne Snipes replace himself as member-at-large upper state, and Todd Black replace himself as member-at-large lower state. MSC.

Bro. David Brown gave a report for the Free Will Baptist Foundation. The Foundation offers seminars that can be conducted at our churches and help our members set up our estates to help remember FWB's after we have gone to be with the Lord. They also offer money management trusts.

Bro. Mike Edwards brought greetings on behalf of President Pinson and Welch College. The college had the largest increase in attendance for the last decade. A new soccer program is starting in the coming fall semester. The college thanks SC churches for all they do.

Bro. Mike Allison brought greetings from the FWB Family Ministries, Greenville, TN. The home is currently working with about 140 to 150 children, of that number 58 are in foster care. In the past year 125 youth accepted Christ. Have had 4494 youth use their camps. There have been 98 babies born at the Hope Center. They are currently in the process of building a maternity home for young mothers. A new Family Resource Center has been started. A contract has also been signed with the Veterans group. They have also started to work at a 60+ bed assisted living facility.

Bro. Donnie Miles shares a report from the FWB Board of Retirement. The 403 (b) 9 plan was explained and how it benefits those in Christian service jobs. Information can be found at boardofretirement.com. All ministers were encouraged to have a retirement plan.

Bro. Neil Morgan gave a report on the work in Spain. There is a great need to share the hope of Jesus to the world. We are planning to go back to our ministry in Spain in June of 2018.

Bro. Fernando Bustamante gave a report on the Hispanic ministry. Souls are being won in our ministries. Thank you to the SC churches for the prayers and support. Report received as information.

Greetings from Randall House and from Ron Hunter. Randall House is working together with the church and the home in a partnership for discipling families. God gave the discipleship mandate in Deut. 6. Randall House exists to help in this partnership, the program is called generational discipleship. Churches are encouraged to use the 6 curriculums available. Many other items are available for purchase. Randall House also has some material to help in rearing teens. All the Randall House resources are available through the SCFWB State Office Bookstore.

The nominating committee recommends Bro. Sherwood Lee to replace himself as moderator of the SCFWB State Executive Board. MSC The nomination committee recommends that Brothers Monty Guffey, Joe Postlewaite, Ray Cribb, John Matthews, and John Cody be elected as the Resolutions Committee with Bro. John Matthews acting as the chairman for the committee. MSC

The nomination committee recommends that Brothers Jody Winn, Wayne Snipes, Sammy Sutton, Charles Mosley, and Randy Thomas be elected as the nomination committee with bro. Jody Winn to serve as the chairman. MSC.

State Home Missions report given. The Home Missions board is seeking a God-called man for a new work in Moncks Corner. The board also reported that we currently have 10 churches without pastors. The board is working with retired pastors to help fill pulpits for churches currently looking for pastors. Bro. Randy Valandingham gave his report for Rejoice Fellowship FWB Church in Aiken, SC. He offered thanks for all who have been praying for the work in Aiken. During the past year the church has seen 18 salvation decisions, 12 baptisms, 3 rededications, and 5 new families added to the church. Bro. Randy has been able to go from no salary to some salary, no home to a mobile home. A new work has many different challenges. Report submitted by Bro. Tim Larrimore and the Home Missions Board. Bro. Scott Ard gave the Final Credentials and Finance Committee Report. We have 5 conferences represented, 104 churches, received \$24,440 in fees/dues, 50 ministers, 11 delegates, 10 national reps, 1 missionary, and 17 visitors with a total attendance of 89. Motion to receive as information. MSC

We have performed the procedures enumerated below, which were agreed to by the SC State Association of Original Free Will Baptists, Inc. and its State Moderator, solely to assist you with a test of accountability for cash receipts and disbursements of the SC State Association of Original FWB, Inc. as of December 31, 2017. The SC State Association of Original Free Will Baptists, Inc.'s management is responsible for the organization's accounting records. This agreed-upon procedures engagement was conducted inaccordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of the parties specified in the report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Our procedures were as follows:

- 1. We obtained an understanding of the accounting procedures of the SC State Association of Original FWB, Inc. as of December 31, 2017, as they relate to cash receipts and disbursements and make recommendations for any changes we deem appropriate.
- 2. We selected a sample of twenty-five (25) disbursements from the population of the organization's checking and savings accounts and perform the following procedures:
 - a. Examined supporting documentation, such as invoices, purchase orders, requisitions, etc. for existence, approval and cancellation in support of disbursements.
 - b. Examined cancelled checks for proper payee, date and amount as recorded in the general ledger and supported by the underlying documentation.
 - c. Examined canceled checks for authorized signatures.
 - d. Traced the transactions into the general ledger, noting the appropriateness of the account distribution.
- 3. We selected three (3) weekly batches of receipts and examined the processing of transactions and perform the following:
 - a. Calculated documentation for clerical accuracy.
 - b. Determined the receipts per the daily receipt summary were properly deposited to the bank.
 - c. Determined the receipts per the daily receipt summary were properly posted to the general ledger.
- 4. We selected ten (10) items from each of the three weekly batched selected above and traced them to the intended designations or beneficiaries.
- 5. For all bank accounts we compared the December 31, 2017, balances in the general ledger and the balances on the December 31, 2017 report sent to the state office to the reconciled bank statements to verify completeness of funds.


