Bro. Tim Larrimore gave the Home Missions Report. Bro. Randy Valandingham gave an update on the Aiken mission work (Rejoice FWB Church). The church is planning to live off the budget for 2020. They desire to be self-supporting at the end of 2020. There will be a new work beginning in Moncks Corner, SC in 2020. Bro. Frank Dillon has agreed to begin this work with the Home Missions Board. Bro. Fernando gave an update on the Hispanic missions work in SC. There were 36 baptisms in 2018, a real good year. There have been about 20 saved in the church in Charleston. In Conway there are 15 new people, in Columbia there are 10, in Florence there are about 20. There is a need for another building in Conway – have reached capacity in the current location. Church in Mexico is doing very well. Motion to receive report as submitted. MSC

Bro. Mike Jones gave the Friends of India (FOI) report. If every FWB church could give \$75 monthly it could fund an evangelist, per giving church, in India. They are averaging winning 2 souls to Christ monthly. Motion to receive report as submitted. MSC.

#### Break

For the break we broke up into prayer teams. Each team gathered in a location and we took the time to speak to God on behalf of our state and the specific needs of our state's churches and preachers.

Meeting resumed after break with our Thursday morning message.

Message offered by Bro. Joel Stone on the Urgency of Prayer, Luke 23:39-43.

Prior to our break for lunch we were reminded about the displays that are set up for all to see. The Resolutions Committee will receive any resolutions that are to be submitted to the state. Lunch to be provided in the fellowship hall. Meeting will begin back at 1 pm. Bro. David Carlson asked blessings on the meal.

Afternoon session began at 1 pm with a devotion by Bro. Wayne Skipper from 1 Peter 3:1-6 on, "Intercessory Prayer."

Report given by Dr. Don Hanna and Bro. Carlise Hanna on the work in India. There are 2 new areas in India where

land has been purchased with the hope of building a church in the future. Our Christian brothers/sisters in Christ in India are still enduring persecution. In 2018 at least 500 people followed Christ in believer's baptism.

Bro. Teddy Rabon gave the Youth report. Motion to receive report as submitted. MSC

Bro. Scott Ard presented the Rabon family with a plaque to honor them for all the years they have worked with our SC youth.

Bro. David Carlson gave the Teen Camp report. Teen camp will be held July 26-28 at Camp Pee Dee, cost is \$135, theme; Sailing with the Savior – Climb Aboard the Disciple Ship. Junior camp is July 29 – August 1, cost is \$135. Motion to receive youth report as submitted. MSC

Moderator read nominating committee recommendations for the Youth Ministries Board. Replacing Teddy Rabon will be David Carlson. Motion entertained to receive these recommendations as submitted. MSC

Bro. Keith Burden gave a report from the Executive Office of the NAFWB. He encouraged everyone to receive One Magazine. Thanks was expressed to the Free Will Baptist Foundation for helping fund "Pulpit" that is made available to FWB preachers. National Convention will be held in Cincinnati, Ohio, July 21-24, 2019. Details about the program will be in the upcoming issue of One magazine. The Executive office has completed the development of a revitalization program for our churches that is called "Rekindle" with administration duties handled by Dr. Danny Dwyer. Bro. Burden expressed appreciation for the 17 years he has been able to serve as the Executive Secretary. Received as information.

Bro. Clint Morgan gave a report on our International Foreign Missions. Some good news, the year was ended in the black. All missionary deficits were erased by the end of the year. The state of SC has the longest serving missionary and many of the youngest missionaries as well. Our missionaries are doing well in the work for the Lord. The Johnson's, Morgan's, and Postlewait's are all doing great work for FWB. SC churches are doing well in giving to international missions, thank you for your support, SC churches gave \$577,800 to support missions in 2018. Please continue to support our World Missions Offering (just over \$24,000 in 2018). When we give to World Missions Offering we are helping missions all around the world. Received as information.

Sis. Elizabeth Hodges gave a report for the WNAC. The WNAC is here to help each woman fulfill the great commission. The WNAC is an established ministry since June of 1935. The WNAC gave over ½ million dollars to ministry causes in 2018. One of the ministries that many are familiar with is the Provision Closet. The Provision Closet met over 203 needs in 2018. This is a way to encourage our international sisters. The WNAC has 3 different scholarships and in 2018 \$8500 in scholarships were awarded to 15 different students. A grant allowed us to have a Shine conference to teach young ladies that they have an identity in Christ. This has been shared in 17 states with over 600 people attending. Another ministry is Treasure and will become a free online resource in Dec. 2019 for women. The WNAC will now be having regional events to help our ladies to connect with each other. There is a desire to connect with our church ladies on social media. The WNAC is available on Facebook. Received as information.

Bro. Rick Bowling gave a report for the North American Ministries. Thank you for all the prayers and generous giving. Gave some details regarding the replacement of the roof at the San Juan church. Everything that is planned to be done in 2019 will allow this church to get back involved in the ministry as it was prior to the hurricane, please pray for this. Thank you to disaster relief that has been so instrumental is accomplishing this great work. We're still building churches in North America. Currently we have 51 church planters, 38 plants, 382 salvation decisions in 2018, 143 baptisms, and 4154 first time guests at our churches. We have 5 Army Chaplains, 2 Navy Chaplains, 1 Guard Chaplain, and 1 Army Reserve Chaplain. Our current Una Hispanic church has purchased some property and the work is growing. Please pray for these works. Received as information.

Randall House gave a report. We are in the process of sending mailers to targeted Methodists to consider FWB curriculum due to the current trending in their churches. We have a great partnership with the SC state bookstore. One really important question, "What if what happened in church also happened in the home?" We need to speak at home what we hear and learn at church. Our curriculum is focused on questions of life. Our mission is building believers at church and home. In June the final commentary of the New Testament, the gospel of Luke, will be completed. Please let us know how we can serve you better. Received as information.

Bro. Mike Edwards gave a report for Welch college. Greetings and thank you for your support. The mission of Welch College is to educate leaders to serve Christ, His church, and His world through biblical thought and life and we're on mission to do that. Every student at Welch college graduates with two degrees. All students will graduate with a degree in Bible. There are more that 40-degree programs at Welch college, but we can't fulfill our mission without the support of the SC FWB churches. We are thankful for the giving to the Welch fund; it is used to offer scholarships to students. Welch now offers a Masters Degree program for educators. We invite everyone to join the Torch Bearer's club. Thank you for your support. Received as information.

Bro. John Brummit gave a report for the FWB Board of Retirement. We encourage everyone to start a retirement plan. The board conducted a benchmarking study to compare plans that are available for FWB. Our plan is the best available plan. We began an instructional program for churches to set up accounts to prepare for opportunities that come available. We are working to become more technologically advanced for easier access. We are trying to do more to provide financial education for FWB's. Much of this is available on the website. Received as information.

Bro. David Brown gave a report from the FWB Foundation. Shared some passages from the Bible teaching the importance of reaching the next generation. Our ministry is to encourage FWB's to give some of their assets back to the Kingdom of God's work. We offer seminars to help church members learn how to make estate plans that include the FWB Foundation. The FWB ministries can also be helped through planned giving. We offer brochures that help people understand the products we offer. Our website has information regarding grants that are available for FWB's. Let's share our assets with FWB's for our future. Received as information.

Bro. Jim McComas gave a report for the FWB Family Ministries. This year we celebrate our 80<sup>th</sup> anniversary. Our ministry is a very large ministry with over 200 employees across several states. At any given time, we have between 100-150 children. We have assisted living centers and crisis pregnancy centers. At the end of December, we showed a profit from a previous year of losses. We are working towards a FWB drug and treatment center as a long-term goal. Thank you for partnering with us. Received as information.

We have performed the procedures enumerated below, which were agreed to by the South Carolina State Association of Original Free Will Baptists, Inc. and its State Moderator, solely to assist you with a test of accountability for cash receipts and disbursements of the South Carolina State Association of Original Free Will Baptists, Inc. as of December 31, 2018. The South Carolina State Association of Original Free Will Baptists, Inc.'s management is responsible for the organization's accounting records. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of the parties specified in the report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

#### Our procedures were as follows:

- 1. We obtained an understanding of the accounting procedures of the South Carolina State Association of Original Free Will Baptists, Inc. as of December 31, 2018, as they relate to cash receipts and disbursements and make recommendations for any changes we deem appropriate.
- 2. We selected a sample of twenty-five (25) disbursements from the population of the organization's checking and savings accounts and perform the following procedures:
  - a. Examined supporting documentation, such as invoices, purchase orders, requisitions, etc. for existence, approval and cancellation in support of disbursements.

- b. Examined cancelled checks for proper payee, date and amount as recorded in the general ledger and supported by the underlying documentation.
- c. Examined canceled checks for authorized signatures.
- d. Traced the transactions into the general ledger, noting the appropriateness of the account distribution.
- 3. We selected three (3) weekly batches of receipts and examined the processing of transactions and perform the following:
  - a. Calculated documentation for clerical accuracy.
  - b. Determined the receipts per the daily receipt summary were properly deposited to the bank.
  - c. Determined the receipts per the daily receipt summary were properly posted to the general ledger.
- 4. We selected ten (10) items from each of the three weekly batched selected above and traced them to the intended designations or beneficiaries.
- 5. For all bank accounts we compared the December 31, 2018, balances in the general ledger and the balances on the December 31, 2018 report sent to the state office to the reconciled bank statements to verify completeness of funds.

See the attached Summary of Results for further detail of the procedures performed and our findings of these procedures.

We were not engaged to, and did not conduct an audit, the objective of which would be the expression of any opinion of the accounting records. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.
