Pray for the boys in the hostel, we have 56 now. Five students are in Bible school preparing for the ministry, please pray for them. We are working on a building to create classrooms to start a Christian school. Thank you for supporting the work in India. Please continue to stand with us.

Bro. Donnie McDonald brings the **International Missions** report. The International Missions report was given with the following information. Our mission is to labor with the body of Christ to fulfill the Great Commission. IM continues with 4 main opportunities: 1. E-teams provide cross cultural mission opportunities for high school students every summer. 2. CMP – College Missions Programs allow college-aged students to serve short term with IM missionaries and participate in IM ministries around the world. 3. The Hanna Project offers short term experiences to share Help, Hope, and Healing through its humanitarian efforts around the world. 4. Go Global – Interactive Go Global workshops raise mission's awareness in local churches, association meetings, and state meetings. The IM also

continues with IM Global Partnerships around the world. Recently new partnerships in Bangladesh and Pakistan are providing new opportunities for the gospel to expand in those regions. IM appointed 8 new missionaries in 2022. The total income for 2022 was over \$8.8 million making it possible for the gospel to expand in even greater ways. Motion to receive report. MSC

Jacob gives a report on the Southern France Hanna Project. Jacob is working to win the Muslim community to the Lord in Southern France.

David Aycock gives a report from Brazil. Details can be found in his handout. Appointed in 1996 and arrived in Brazil in December 1997. For the first 2 ½ years all the services were held in Bro. Aycock’s home. Afterwards the Lord blessed with a building. Last year they saw eight accept Jesus as their Lord and Savior. Most of their evangelism work is through Bible study programs. They have a lot of work through youth outreach. They are currently responsible for two congregations in the Brazil area. They are also offering Bible college courses through their seminary with eleven students currently attending. The Lord allowed them to begin a Christian school in 2022 with five students. They have already seen souls saved from the Christian school. They have fourteen students in the school for this current school year. The school is currently not self-sustaining. They would need an average of ten students per class to be self-sustaining. They are currently in need of \$50,000 to enclose a building. Please keep the Aycock’s and the mission work in Brazil in our prayers.

David Carlson gives the **Youth Camp Ministries report.** Motion to receive report as information. MSC Greetings from the SC FWB State Youth Ministries Board.

This last year our state had an exciting weekend of youth camp at Look Up Lodge in Travelers Rest South Carolina. The camp was held on September 16,17,18 with both age groups Juniors (8-12 year old) and Teens (13- 18 year old) came at the same time. Juniors filled up cabins and teens filled up other cabins.

Rev. Shiloh Hackett preached messages on Friday night, Saturday morning and Sunday morning. Brother Shiloh connected with the youth so well on their level. Many came to the altar getting closer to God and making decisions for salvation and re-dedication. Saturday morning we separated the teens and juniors for separate services and that went real well. On Saturday night we had a campfire service with Andy Moore bringing the message. He was so awesome and truly brought a heart for the youth and a love for the word of God. I also asked for 2 testimonies at the campfire and many kept on sharing what God has done for them. Finally, a boy raised his hand and said I thought you just said two. Amen.

Look-up Lodge scenery is a beautiful get away nestled around a lake with a walk to a waterfall. The youth enjoyed fishing, paddle boats, canoes, paddle boards, water slide, swimming, zip-line, and giant swing around the lake. The sports field has basketball, waffle ball, soccer, basketball, ping pong, four square, and carpet ball. The cafeteria is fully staffed with their own workers. The meals were really good and there was a real nice salad bar at each meal. At one break time their staff did the planned activities with our group. There is so much to tell and this facility is a big upgrade from our last place we rented.

This year we have also rented Look Up Lodge for the third weekend in September 15,16,17. Rev. Noah Emory will be our speaker for the weekend. He is a young man on fire for the Lord from Clover SC. He is in evangelistic ministry and we look forward to God using him to minister to our youth. Applications and information for camp are at the youth ministries table.

The Youth Ministries Board has an enclosed trailer with inflatables and other equipment in it. Due to liabilities and not needing these items for camp anymore they will be sold. They are being made available for our churches to buy first. The board will accept sealed bids with a cut off date of June 1. An itemized list of items and instructions are at the youth ministries table.

The board would like to thank the churches who have our ministry in your church budget. Your vision to support us in our ministry is appreciated.

Todd Parrish gives report from **Welch college.**

Greetings from Welch College. Thank you for your prayers and support to Welch college. SC was the number 4 state in giving to the college, giving over \$145,000. Some praise items from the college, the enrollment is now back up by around 15% after Covid. Total enrollment is in the mid-400's. Students enrolled at Welch came from 22 states, 1 US territory, and 6 foreign countries for the last year terms. We saw an increase in the total number of preacher boys. Preacher boys can receive an annual \$10,000 scholarship if they will commit to serving in a FWB church and receive a recommendation from their FWB pastor. As of January 31st the admit numbers are high and moving in the right direction. Welch offers graduate education in a Master's program and this program is also available in an online format. Upcoming interests, Welch College has a giving Tuesday to help with scholarship needs. Total for giving Tuesday was \$135,000. Please continue to pray and send young students to Welch College.

Joel Stone gives report on **CTS.** Motion to receive as information. MSC

Last year (2022) the state of SC only had 1 to compete in the CTS program. This year (2023) we have 12 competing in the CTS program. How do we increase the number of contestants in the CTS program. It will take our pastor's and churches to get onboard this program. CTS is one of the greatest ways to teach our children the Word of God. The SC state competition will be April 29 at Peach FWB Church. Please pray for the CTS program in SC.

Steve Berry gives report from **Southeastern FWB College:** Bro. Berry encourages all churches to have the ensemble to come minister at our churches. The college currently has 33 pastoral students. Our emphasis is training students for local church ministry. Our desire is to reach the next generation with the gospel. We have a new upcoming four year program that will be announced when we are able. We are celebrating our 40th year of ministry. Our spring conference is April 10-11, 2022. The college website has additional information for you to stay updated on what is happening at Southeastern. Please look at youthflame.com to see programs for your church youth.

Tim Moore gives report from the **Turbeville Children's Home**

SC FWB churches birthed the ministry 72 years ago and the ministry is still going strong. God is using the home to help children to see Jesus. Thank you to the SC churches for feeding into this ministry. All are welcome to come and see what is happening on the campus of the Turbeville Children's Home ministry.

Mike Allison gives report from the **Greenville Children's Home.** Thank you for everything that you have done and are doing for FWB Family Ministries Children's Home & Hope Center in Greenville, TN. Our ministry includes our campus in Greenville, TN, The Oaks Retreat Youth Camp & Church Retreat in Greenville, TN, three Children's Homes in Arkansas, our Hope Center in Greenville, TN and two assisted-living facilities (one in Wise, VA and one in Erwin, TN). Rev. Jim McComas is our Executive Director/CEO and Bro. Jim Robinette is our Chief Operating Officer. The ministry was founded in 1939 and we're in our 84th year as a ministry. We are currently serving 140-150 children on a daily basis. That includes around 50-60 children in Foster Care. We have between 6 & 8 teenagers in our Drug & Alcohol Program. The Oaks Retreat Youth Camp & Church Retreat had 3400 campers in 2022. We are currently serving over 100 senior citizens in our two assisted-living facilities. We had 55 souls saved in 2022 throughout our ministry. The Hope Center (pregnancy crisis center) had 37 babies born in 2022. Our Maternity Home is now open. David Brown, Director **of FWB Foundation** gave a report from FWB Foundation. The Foundation exists to serve other FWB ministries. We do this through Planned Gifts, Endowment Grants, Estate Planning and gifts to ministries. More information regarding the Foundation can be found on the NAFWB website. In 2022 the Foundation gave away 1.1 million dollars. The Foundation has plans to prioritize how to give money back to the denomination. They also have scholarships for pastors. They are working to develop a benevolent program.

Brandon Smith gives report from **NA Home Missions**. Report is on the mission work in Hickory, NC. This is a joint project with NC and North American Home Missions. The mission board of NC has given the clearance to start the church. They have eighteen people committed to start the church. Currently purchasing church equipment. Church will be portable in the beginning. The name of the church is the Equip Free Will Baptist Church. Preview services will be starting in May, from May to August they will hold one service monthly as they grow. Please keep Equip FWB Church in your prayers.

Rick Bowling gives report on **Hispanic work, North American ministries**. Our focus is to build churches. They are reporting in the black again, God is blessing. We have fantastic leaders.
