

Bro. Chris Todd gave a report regarding the state office properties. The children's home is wanting to purchase 4 acres of property to build a family life center.

The Disaster Relief Board would like to fence in the remaining pasture area at the state office for various needs. Area would be fenced in and equipped with a locking gate.

The National website now has an online directory of our churches. The National office is requesting our churches to send a picture of each church to be attached to the directory. They would also like a short video with some introductory information regarding each church. Churches are encouraged to attend the Leadership conference.

# January 13, 2020 INDEPENDENT ACCOUNTANT'S REPORT ON APPLYING AGREED-UPON PROCEDURES

South Carolina State Association of Original Free Will Baptists, Inc. Sherwood Lee, State Moderator - P.O. Box 9, Turbeville, South Carolina 26162

We have performed the procedures enumerated below, which were agreed to by the South Carolina State Association of Original Free Will Baptists, Inc. and its State Moderator, solely to assist you with a test of accountability for cash receipts and disbursements of the South Carolina State Association of Original Free Will Baptists, Inc. as of December 31, 2019. The South Carolina State Association of Original Free Will Baptists, Inc.'s management is responsible for the organization's accounting records. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of the parties specified in the report. Consequently, we make no representation regarding the sufficiency of the

procedures described below either for the purpose for which this report has been requested or for any other purpose. Our procedures were as follows:

- 1. We obtained an understanding of the accounting procedures of the South Carolina State Association of Original Free Will Baptists, Inc. as of December 31, 2019, as they relate to cash receipts and disbursements and make recommendations for any changes we deem appropriate.
- 2. We selected a sample of twenty-five (25) disbursements from the population of the organization's checking and savings accounts and perform the following procedures:
  - a. Examined supporting documentation, such as invoices, purchase orders, requisitions, etc. for existence, approval and cancellation in support of disbursements.
  - b. Examined cancelled checks for proper payee, date and amount as recorded in the general ledger and supported by the underlying documentation.
  - c. Examined canceled checks for authorized signatures.
  - d. Traced the transactions into the general ledger, noting the appropriateness of the account distribution.
- 3. We selected three (3) weekly batches of receipts and examined the processing of transactions and perform the following:
  - a. Calculated documentation for clerical accuracy.
  - b. Determined the receipts per the daily receipt summary were properly deposited to the bank.
  - c. Determined the receipts per the daily receipt summary were properly posted to the general ledger.
- 4. We selected ten (10) items from each of the three weekly batched selected above and traced them to the intended designations or beneficiaries.
- 5. For all bank accounts we compared the December 31, 2019, balances in the general ledger and the balances on the December 31, 2019 report sent to the state office to the reconciled bank statements to verify completeness of funds.

See the attached Summary of Results for further detail of the procedures performed and our findings of these procedures.

We were not engaged to, and did not conduct an audit, the objective of which would be the expression of any opinion of the accounting records. Accordingly, we do not express such an opinion. Had we performed additional procedures; other matters might have come to our attention that would have been reported to you.

This report is intended solely for the information and use of the South Carolina State Association of Original Free Will Baptists, Inc. and its State Moderator, and is not intended to be and should not be used by anyone other than these specified parties.

A look at the weather map below which tracked named storms in the Eastern Atlantic demonstrates what seems to be a buffer of protection around the continental United States with regard to hurricanes. In disaster relief no news is good news! We praise the Lord for a break from disaster. But that doesn't mean that we sit on our hands and watch the world go by. The board also spoke about having some of our current retired pastors, be able to share the works of home missions. A possibility of Acts 16:9 fund that would go to help these missions.


